Schedule No. D-1

DOMESTIC SERVICE

APPLICABILITY

This schedule applies to domestic lighting, heating, cooking, and single phase domestic power service in single-family dwelling units and in flats, apartments, or mobile homes separately metered by the utility, and to all single-phase farm service on premises operated by the person whose residence is supplied through the same meter.

This Domestic Service shall not be applicable to, or available for, three-phase service, resale for profit, temporary construction service, standby or auxiliary service, service to any single motor exceeding a nameplate rating of 7½ horsepower, or any equipment which will cause excessive voltage fluctuations.

TERRITORY

The entire area served by the City of Lompoc Electrical Utility.

CHARGES

The following charges are effective with bills issued on and after the indicated dates:

SPECIAL CONDITIONS

1. This rate does not apply in the following instances (but not limited to these circumstances):

- a) When applied to apartment houses, flats, groups of apartments, mobile home parks or other multi-residential circumstances receiving service through one (master) meter, the service will be billed on the applicable commercial or mobile home rate schedule.
- b) When a business or commercial establishment is conducted in conjunction with a residence and both are measured through one meter, this schedule does not apply; however, the applicable commercial schedule applies. A residence, otherwise eligible for this schedule, with a valid home occupancy use permit, qualifies for service under this rate schedule.
- c) This rate does not apply to individually metered service for common area and common facilities (such as laundry rooms or community recreation facilities) in multi-family dwellings where the individual units are individually metered. Such service will be billed on the applicable commercial rate structure.

2. Miscellaneous

For customers who use service for only part of the year, this schedule is applicable only to an annual contract.

3. Life Support Devices

A residential customer who certifies in writing that regular use of a medical life support device, as defined below, is essential to maintain the life of a full-time resident of the household is eligible for the Tier 2 Energy Rate for the first 1,500 kWh of usage. Certification by a doctor of medicine or osteopathy licensed to practice medicine in the State of California that a particular device is necessary to sustain the user's life may be required to be provided to the Utility prior to the residential customer receiving the benefit. This benefit will be available effective with the first full monthly billing cycle following application by the customer and verification thereof by the Utility.

A life support device is defined as any medical device requiring Utility supported energy for its operation that is regularly required to maintain the life of a person residing in a residential unit. The term includes respirators, iron lungs, hemodialysis machines, suction machines, electric nerve stimulators, pressure pads and pumps, aerosol tents, electrostatic and ultrasonic nebulizers, compressors, IPPB machines and motorized wheelchairs. The term does not include therapeutic devices such as whirlpool pumps, heating pads, vaporizers, and humidifiers.

4. Space Heating

Residential customers with electric space heating as the principal source of home heating will be charged the Tier 2 Energy Rate for kilowatt usage from 326 to 1500 kWh during the seven months of November through May, inclusive. The Tier 1 Energy Rate applies to the first 325 kWh of usage. This benefit will be available effective with the first full monthly billing cycle following application by the customer and verification thereof by the Utility. Customers are eligible for this discount only if they were a customer of the City of Lompoc on December 31, 2007, the customer was receiving this discount as of December 31, 2007, and is currently receiving their service at the same address as they received service on December 31, 2007, with no lapse in service.
