SUBJECT: Federal Aviation Administration Apron Rehabilitation Grant Application;

Adoption of Resolution No. 5492(14)

Recommendation:

Staff recommends the City Council adopt Resolution No. 5492(14) (attached) authorizing the City Administrator, Assistant City Administrator, Public Works Director, Assistant Public Works Director, or the Aviation/Transportation Administrator to execute and file the necessary documents for the purpose of obtaining financial assistance provided by the Federal Aviation Administration (FAA) for rehabilitation of ramp area at the Lompoc Airport.

Background:

Staff is applying for a grant from the FAA for the rehabilitation of approximately 22,000 square feet of ramp area at the Lompoc Airport. This ramp area is approximately 30 to 50 years old, and was identified as needing to be rehabilitated by a survey provided by Caltrans in 2011. The rehabilitation project was previously approved in the FY 2013-15 Budget.

Fiscal Impact:

As noted above, the FY 2013-15 Budget included appropriations sufficient for the full estimated cost of \$200,000 for this project, provided sufficient FAA grant funds are awarded. The FAA grant application is for up to approximately \$180,000 of the estimated \$200,000 for this portion of the project. The remaining funds of approximately \$20,000, the required 10% match, are also appropriated as part of the overall project. The initial resources for the match are either Airport Fund reserves for the full 10% match, or a combination of 5.5% from Airport Fund reserves and 4.5% from the State Aeronautic Funds.

The FAA funding requested for this project comes from entitlement funds provided the Lompoc Airport each year for capital projects. The Airport has approximately \$150,000 allocated each year by the FAA and can hold up to three years of entitlement funds in

reserve with the FAA, to utilize for capital projects. The Lompoc Airport last utilized this funding source for a pavement overlay project completed in FY 2011-12.

Conclusion:

It is recommended the City Council adopt Resolution No. 5492(14) authorizing the City Administrator, Assistant City Administrator, Public Works Director, Assistant Public Works Director, or the Aviation/Transportation Administrator to file and execute documents for the purpose of obtaining financial assistance provided by the FAA.
