SUBJECT: Request for General Fund Allocation of \$25,000 to Fiscal Year 2015-16

Human Service Fund

#### **Recommendation:**

Staff recommends the City Council consider the Human Services Commission's request to allocate \$25,000 to the Fiscal Year 2015-16 Human Service Fund.

#### Background:

The City of Lompoc provides grants to non-profit agencies on an annual basis for human service activities, also known as public service activities. Funds for such grants are comprised of:

- Santa Barbara County Community Development Block Grant Urban County Partnership (CDBG-UCP);
- City of Lompoc Community Development Block Grant Program Income (CDBG-PI); and
- Human Service Fund Donations (Utility Billing Donations and Comcast Franchise Payment).

Up to 15 percent of the total allocation of Santa Barbara County CDBG-UCP funds can be used for human service activities. The County of Santa Barbara calculates the amount for each participating jurisdiction in the Urban County Partnership based upon a formula from the U.S. Department of Housing and Urban Development (HUD). The City of Lompoc has received the following CDBG-UCP funds:

Per Title 24: Housing and Urban Development Part 570 – Community Development Block Grants, 24 CFR subsection 570.201(e)(1), "the amount of CDBG funds used for public services shall not exceed 15 percent of each grant, ... plus 15 percent of program

income..." received during the grantee's immediately preceding program year. It is important to note that 15 percent is the maximum amount that can be used for public service activities, not a minimum amount. Jurisdictions are not required to allocate funds to public service activities (although many needs and CDBG objectives could be met by doing so in Lompoc).

Human Service Fund Donations consist of funds received from the annual utility billing customer donation campaign, as well as a contribution required from Comcast Cable in the amount of \$25,000 annually. The amount received through the utility billing donations has averaged between \$15,000 and \$18,000 annually. One hundred percent of these funds are passed on to non-profit agencies to provide human service activities.

#### Discussion:

The Human Service Commission recognizes the City of Lompoc, like other jurisdictions, face financial constraints with continuing to fund essential City services. Human Service Fund activities are "essential" and reduce City costs by providing services to the community that could otherwise impact the City.

During fiscal year 2013-14 the following human service activities accomplishments were reported:

The franchise agreement between the City and Comcast included a requirement for Comcast to contribute \$25,000 annually to the Human Services Commission for Human Services Commission activities. The State of California's cable franchise will replace the City's franchise on January 1, 2015. The State's franchise does not require Comcast to continue the annual contribution and Comcast has indicated they will cease the annual payment. The final payment was received for the 2014 franchise year in December 2013. The loss of the Comcast \$25,000 annual contribution will result in a 21 percent decrease in funding available for the FY 2015-16 Human Service Fund.

Neighboring jurisdictions recognize the limited amount of funding available through CDBG funding and many have made available their General Funds for human services programs in their jurisdictions as follows:

#### **Fiscal Impact:**

At their meeting of August 4, 2014, the Human Services Commission directed staff to request the Council consider a contribution of \$25,000 from the General Fund to the Human Service Fund for FY 2015-16. The Notice of Funding Availability (NOFA) for the FY 2015-16 process begins in the fall of 2014, and the Human Services Commission desires to include the requested contribution in the NOFA process. Lack of contribution from the General Fund potentially will negatively impact seven agencies (if we use the FY 2013-14 funding listed in the previous table of Projects and Activities as a reference).

The most recently published audited financial information for the fiscal year ending June 30, 2013, indicates the Human Services Fund to have \$56,246 in Unrestricted Fund Balance. Over the past 12 years, Unrestricted Fund Balance has fluctuated between \$48,228 as of June 30, 2005 and \$79,019 as of June 30, 2012. Based on the average expenditure of funds for program activities of \$43,147 between FY 2002-2003 and 2013-2014, the fund's reserves have fluctuated between 112 percent and 169 percent

of expenditures. In comparison, the General Fund's Unrestricted Fund Balance reserves at June 30, 2013, were 17.6 percent of expenditures.

#### **Conclusion:**

The Human Services Commission has been charged with the duty of assessing community needs and requests and to provide the City Council with recommendations for fiscal support. The City Council is respectfully requested to support an allocation of \$25,000 General Fund monies to the Human Service Fund.

The loss of the Comcast \$25,000 annual contribution will result in a 21% decrease in funding available for the 2015-16 Human Services Fund, this decrease results in a loss of services to 7,121 Lompoc residents.

The loss of the Comcast annual contribution is not the only decrease this fund is experiencing. Over the years the Community Development Block Grant allocation has decreased as well. Ten years ago the Human Service Commission was able to allocate \$178,000 to serve Lompoc residents. The estimated amount that will be available if the City Council does not approve a contribution to the Human Service Fund is \$70,987 3% decrease from prior year \$54,987 + \$16,000 Utility Billing (Estimating: Contributions). This is a decrease over the past ten years of 61%.
