Re: Frick Springs Bridge Replacement - Proposal for Engineering Services

Dear Eric:

Thank you for requesting a proposal from Garing Taylor & Associates for engineering services related to the existing Frick Springs Pedestrian Bridge. We look forward to working with you.

We have reviewed the existing 40 foot pedestrian bridge and found it to be in a weakened state with dry rot evident in the supporting timbers. Based on it's existing condition GTA has recommended that the bridge be closed. Construction access to and around the site is constrained and we recommend that a simple span bridge with timber supports be used to replace the existing structure. We designed a similar pedestrian bridge with glu lam beams in the City of Santa Maria with a span of 45 feet that had a construction cost of approximately \$50,000. Pictures of this bridge are enclosed for your review. Based on implementation of a similar bridge at the site, we can offer you the following services:

1. Bridge Construction Documents

GTA will coordinate the efforts of a Soils Engineer to perform a geotechnical investigation of the site and prepare recommendations for the foundation of the bridge. Based on those recommendations, we will prepare a set of construction documents and specifications for the bridge. The plans and specifications will be submitted to the City for review and approval.

During the bidding process, GTA will review RFIs, answer contractor's questions and prepare addenda if needed to facilitate the award of the construction contract.

Exclusions

- 1. This proposal does not include construction administative or management services.
- 2. This proposal does include soils engineering services.

3. The City shall provide any available as-built plans of the existing improvements.

TERMS OF SERVICE AND COMPENSATION




