REFUSE COLLECTION RATES - Effective June 1, 2010, the rates set forth in Exhibits 1 - 4, shall be charged for the collection (in City-supplied containers), removal, and disposal of garbage, rubbish and waste matter in the City.

A. Single Family Residential - Exhibit 1.

Rates are based on size of refuse container. Service to include one each 95-gallon commingled and/or greenwaste recycling container upon request, collected weekly.

For the purpose of this Resolution, "single-family residence" means a detached house, duplex, or triplex on a single assessor's parcel.

B. Multi-Family Residential – Exhibit 2.

Rates are based on basic service, which is billed to each unit for twice per week collection. Additional collections can be made per special request and will be billed to the property owner or agent.

"Multi-family residences" include apartment houses, bungalows, complexes, condominiums, flats, and trailer parks. For the purpose of this Resolution, "multi-family residential" does not include motels and hotels.

C. Commercial – Exhibit 3.

Service is provided in 95-, 300-, or 450-gallon containers, up to five times per week.

Rates are based on size of refuse container(s) and frequency of collection, and include 95-gallon commingled and/or greenwaste recycling container(s) upon request.

D. Special and Annual Events – Exhibit 4.

E. Adequate Service.

The City retains the right to place additional containers and/or provide additional collection/removal services should the owner(s) fail to maintain adequate refuse containers and service. The City retains the right to bill the property owner or agent for these additional containers and/or collection/removal services.

F. Container Exchange.

When a container is delivered to a customer, the owner has 60 days, from the date of requesting service, to determine his/her container size and/or scheduling requirements. Thereafter, container exchanges more than once per year will be charged a \$12.50 service fee.

G. Outside the City.

The charges for garbage and waste collection outside the City limits are 2.0 times the rates provided in this Resolution for the respective class of service.

H. Special Service.

The Public Works Director or his duly authorized representative, at his discretion, may provide for the collection and removal of rubbish from any place or premises at times in addition to those when regular collection service is made available, or in a manner different from that customarily provided. Any such additional or different service shall be charged at the rate of forty-five dollars (\$45.00) per hour with a minimum charge of twenty-five dollars (\$25.00) per collection.

The Public Works Director, or his duly authorized representative, at his discretion, may provide for free dump service for non-profit organizations providing community clean up. Such service shall be arranged in advance and is limited to a maximum of two (2) tons per event.

A vendor approved by the Public Works Director, or his duly authorized representative, may service any customer that cannot be adequately serviced with the City's automated collection equipment.

I. <u>Damaged Containers</u>.

The City will replace containers damaged beyond normal wear and tear by the customer, with the customer charged for the cost of the new container. Container costs are established by Resolution No. 5136(03), or its successor.

J. Appliance and Tire Collection and Disposal.

Charge for collection by City crews and disposal of appliances and/or tires, from a commercial establishment, are as follows: A special service fee will be charged per Section H, above. In addition, the commercial establishment shall pay all disposal fees at the City of Lompoc Sanitary Landfill as set forth in Landfill Disposal Fees in Exhibit 5.

LANDFILL DISPOSAL FEES – Effective July 1, 2010, the fees set forth in Exhibit 5 shall be charged for the disposal of garbage, rubbish, waste matter, and recyclable materials (originating from the Lompoc Valley Wasteshed) at the City of Lompoc Sanitary Landfill.

A. Recyclables.

- Recyclable materials include clean separated greenwaste, woodwaste, concrete, and metals (other than appliances). All loads must be 100% clean with no exceptions.
- 2. Clean loads of topsoil, if usable for cover material, may be accepted without charge at the discretion of the Public Works Director or his designee.
- Uncontaminated loads of asphalt concrete, if deemed a beneficial use, may be accepted without charge at the discretion of the Public Works Director or his designee.

B. Appliances.

Appliances include air conditioners, refrigerators, freezers, washers, dryers, microwave ovens, or other similar item, which requires special handling to remove hazardous waste such as oil and refrigerant.

C. Electronic Waste.

Electronic waste includes consumer and business electronic equipment that is near or at the end of its useful life. Examples of electronic waste include, but are not limited to, cathode ray tubes (computer monitors and televisions), computers, printers, radios, VCR's, cellular telephones, cordless telephones, and telephone answering machines.

D. Hard-to-Handle Materials.

Hard-to-handle materials include, but are not limited to, contaminated loads requiring special hauling, loads containing materials such as treated wood waste in accordance with California Health and Safety Code Sections 252150.7 and 25150.8, or non-friable asbestos properly wrapped in accordance with California Code of Regulations (CCR), Title 22, Section 66268.14.
