RESOLUTION NO. 5633 (10)

A Resolution of the City Council of the City Of Lompoc, County Of Santa Barbara, State Of California, Adopting Revised Environmental Review Guidelines for the City of Lompoc; and Rescinding Resolution No. 4464(95) (Planning Division File No. TA 10-02)

WHEREAS, pursuant to the California Environmental Quality Act (CEQA, Public Resources Code Sections 2100, et seq.) the State Secretary of Resources has adopted guidelines for implementation of CEQA, commonly referred to as the State CEQA Guidelines, which are contained in 14 Cal. Code Regs. Sections 15000, *et seq.*, and which are binding upon all public agencies in California; and

WHEREAS, Section 15022 of the State CEQA Guidelines provides each public agency shall adopt objectives, criteria and specific procedures, consistent with CEQA and the State CEQA Guidelines, for administering its responsibilities under CEQA; and

WHEREAS, Section 15022 also allows public agencies to adopt the State CEQA Guidelines through incorporation by reference, and if the agency does so, it may then adopt only those specific procedures of provisions necessary to tailor the general provisions of the Guidelines to the specific operations of the agency; and

WHEREAS, in 1981, the City Council of the City Council of the City of Lompoc adopted Resolution No 3024 (81) in order to establish Environmental Review Guidelines for the City of Lompoc and, in 1995, the City Council adopted Resolution No. 4464 (95) adopting amended Environmental Review Guidelines; and

WHEREAS, on April 14, 2010 the Planning Commission, following a duly noticed public hearing, adopted Resolution No. 671 (10) recommending the City Council amend the adopted City of Lompoc Environmental Review Guidelines; and

WHEREAS, on May 18, 2010, the City Council, held a duly noticed public hearing to consider the Planning Commission recommendation.

NOW, THEREFORE, THE CITY COUNCIL RESOLVES AS FOLLOWS:

SECTION 1. Based upon the testimony and other evidence received at the public hearing, staff written and oral analysis, and considering the recommendation made by the Planning Commission, the City Council hereby adopts and incorporates by reference the State CEQA Guidelines, as contained in the 14, Cal. Code Regs. Section 15000, et seq. In addition, the City Council hereby adopts as its Environmental Review Guidelines the attached Exhibit A.

SECTION 2. Resolution 4464 (95) is hereby rescinded.
