RESOLUTION NO. 5665(10)

A Resolution of the Council of the City of Lompoc, County of Santa Barbara, State of California, Amending Resolution No. 5592(09) Modifying Existing Electric Rate Schedule A-13

WHEREAS, the City Council, when acting by Resolution thereof, has the duty and power to establish the rates to be charged for the sale of electrical energy, to set up classifications and schedules for such rates, including the criteria for eligibility for classifications, and to adopt and promulgate rules and regulations necessary for the operation of the electrical distribution system of the City and the collection of electrical charges; and

WHEREAS, the City Council has previously established by Resolution the rates to be charged for the sale of electrical energy and the classifications and schedules for such rates, and has amended said schedules and rates from time to time; and

WHEREAS, the City Council has previously introduced a new rate and schedule to promote and attract large consumers of electrical energy; and

WHEREAS, the City Council now desires to further amend said schedule to promote, attract and retain large consumers of electrical energy,

NOW, THEREFORE, the City Council of the City of Lompoc hereby resolves that:

SECTION 1. The attached schedule, Schedule A-13 (Economic Development Incentive Rate), enhances the City's ability to attract new manufacturing, industrial, and research and development businesses to the City of Lompoc's electric service area.

SECTION 2. The attached schedule, Schedule A-13 (Economic Development Incentive Rate), as modified, will also enhance the City's ability to retain manufacturing, industrial, and research and development businesses who continue to grow in both electrical consumption and in creation of new jobs in the City.

SECTION 3. The attached Schedule A-13 will provide the opportunity for new jobs in the City of Lompoc, thereby enhancing the revitalization of the Lompoc economy.

SECTION 4. Council hereby directs the Management Services Director to adjust the Electric Rate Schedule A-13 to reflect these amendments, copies of which shall be prepared and filed with the City Clerk and attached to this Resolution to become a part of the official public records of the City.

SECTION 5. This Resolution does not amend existing rate adjustments (as of November 3, 2009) for those customers currently billed under Electric Rate Schedule A-13. The rate adjustments for Schedule A-13 are as they were adopted on November 3, 2009 by Resolution No. 5592(09) until such time as amended by further Resolution of this Council.

SECTION 6. This Resolution is effective on and after the day of its adoption.
