**SUBJECT: RESOLUTION NO. 5475(08) DESIGNATING CERTAIN STREETS  
IN THE VICINITY OF RYON PARK FOR PERMIT PARKING DURING  
THE 2008 FLOWER FESTIVAL**

### **RECOMMENDATION:**

That the City Council adopt Resolution No. 5475(08), designating certain streets in the vicinity of Ryon Park for permit parking for residents only during the 2008 Flower Festival.

### **DISCUSSION:**

In 1993, the City Council adopted Ordinance No. 1384(93), which allows by resolution the designation of certain streets during specified dates to which preferential parking restrictions will apply. The intent of the permit parking is to reduce the vehicular traffic congestion in the designated area.

Parking by permit during Flower Festival has been implemented in the vicinity of Ryon Park since 1993. Residents have been pleased with these improvements, which secured parking spaces for their vehicles and reduced traffic. The parking restrictions are noted on Exhibit "A" of Resolution No. 5475(08).

### **Parking Permits:**

As proposed, parking permits (two [2] per resident ONLY) will be issued to each area residence shown on the Resolution Exhibit "A", and parking for the general public will be available at the Lompoc Valley Middle School (Saturday and Sunday), downtown parking lot, and athletic fields at Ryon Park. The parking restrictions will be in effect June 25 - 29, 2008. Warning signs will be posted, which indicate that parking is by permit only. The Police Department intends to issue citations only to vehicles parking without a permit in a permit parking zone.
