

RESOLUTION NO. 5475(08)

A Resolution of the Council of the City of Lompoc  
County of Santa Barbara, State of California,  
Designating Certain Streets In The Vicinity Of Ryon Park For Permit Parking  
During The 2008 Flower Festival

WHEREAS, Section 2071.6 of the Lompoc City Code provides a procedure for limiting parking on certain streets in the vicinity of special events to parking for residents and/or merchants and their guests; and

WHEREAS, Section 2071.6 provides that to implement the permit parking limitation, the City Council shall adopt a resolution designating the streets to which the preferential parking restrictions are to apply to, and thereafter, pursuant to the requirements of Vehicle Code Section 22507, signs or markings giving adequate notice of the parking restrictions are to be placed upon the affected streets and permits as necessary are to be issued to residents and/or merchants adjacent to the streets for their use and the use of their guests, which exempt them from the parking prohibitions or restrictions contained in the resolution; and

WHEREAS, the City Council has determined that it is appropriate to adopt a resolution designating certain streets in the vicinity of Ryon Park for permit parking during the 2008 Flower Festival.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Pursuant to the authority in Section 2071.6 of the Lompoc City Code and Vehicle Code Section 22507, parking on the streets designated herein shall be limited to the preferential parking privileges for residents and/or merchants and their guests during the following days, during the 2008 Flower Festival: Wednesday, June 25, 2008, through Sunday, June 29, 2008.

SECTION 2. The streets to which the preferential parking restrictions contained in this Resolution shall apply as follows, and as further designated on the map attached hereto as **Exhibit "A"**, which is incorporated herein by reference:

313 and 309 South "R" Street;

200 Block of South Rose Street;

200 Block of South Sage Street;

200 Block of South Tulip Street;

"O" Street from Cypress Avenue to Hickory Avenue, East side only;

"O" Street from Hickory Avenue to Olive Avenue;

"N" Street from Ocean Avenue to Olive Avenue, except for the East side of South "N" Street in the 200-300 block adjacent to the Lompoc Middle School, which shall be posted "No Parking";

Cypress Avenue between "N" Street and "O" Street; except for Saturday, June 28, 2008, from 8:00 a.m. to 5:00 p.m., which shall be posted "No Parking," when parade floats are parked for viewing by parade visitors;

Hickory Avenue between "N" Street and "U" Street;

Lime Avenue, from "O" Street to "U" Street, and "P" Street between Lime and Hickory Avenues; and

1100 and 1104 West Cypress Avenue

**SECTION 3.** In accordance with Section 2071.6(B), two (2) permits shall be issued per residential dwelling adjacent to the designated streets, which exempts permit holders from the parking prohibitions or restrictions contained in this Resolution, except parking on Cypress Avenue between "N" Street and "O" Street, Saturday, June 28, 2008, from 8:00 a.m. to 5:00 p.m., when parade floats are parked for viewing by parade visitors. Permits shall be prominently displayed on the dashboards of vehicles, or otherwise made visible. Vehicles not displaying such permits shall be subject to citation.

**SECTION 4.** This Resolution shall be effective immediately.
