SUBJECT: Amendment to Resolution 5437(07) in order to Establish a Process

for Commissioner Appointments to the Human Services Commission to Serve a Concurrent term with a Nominating Council

Person

RECOMMENDATION

That City Council:

- 1) Review and provide direction to staff concerning a proposed process for Human Services Commission Appointments in order for each Commissioner to serve a concurrent term with that of the nominating Councilperson; and
- 2) Approve Resolution 5483(08) to amend Resolution 5437(07) and include a revised appointment process.

BACKGROUND AND DISCUSSION:

In 2007, Council adopted Resolution 5437(07), which authorized the reduction of members on the Human Services Commission from seven (7) Commissioners to five (5) Commissioners, and provided for Commissioners to serve a concurrent term with that of the nominating Councilmember. However, the resolution did not detail the specific process by which the existing Human Services Commissioners' terms would be modified to accommodate this change. The current Commissioners were appointed 'at large' to the Commission. Term lengths are staggered, so that there is continuity among Commissioners and their activities that occur throughout the year.



Two Commission positions are due to expire on June 30, 2008. In order to synchronize Commission tenures with Council members, staff is recommending that Council approve the following changes:

- Extend the terms of these two (2) Commissioners through December 2008; and
- Shorten the term of a third Commissioner to December 2008 from June 2009.
