**BOOSTER PUMP STATION IMPROVEMENTS** 

## **RECOMMENDATION:**

It is recommended that the City Council:

A) Accept Project No. FY-05-W-3 as complete.

B) Instruct the City Clerk to file the required Notice of Completion regarding this project.

#### **BACKGROUND:**

In November of 2002, an energy efficiency analysis was completed for the City's Water Treatment Plant (WTP). The purpose of the energy analysis was to identify inefficient operations and equipment along with recommendations to reduce operating costs. As a result of this study, an Energy Efficiency Analysis Report was prepared. The report concluded that upgrading and rehabilitating the booster pump station would generate the most significant savings. In addition to energy savings, security and safety issues were identified. A preliminary design report for these improvements was completed in June 2004.

Project No. FY-05-W-3 included various improvements of the pumping and power system at the WTP. The project's major items of work included the replacement and reconfiguration of the WTP pump station; construction of a new power building; decommissioning and demolition of the existing power building; upgrading of the instrumentation and control system; and integration with the existing SCADA system.

The Project was noticed, advertised and bid in accordance with the procedures of the Uniform Public Construction Cost Accounting Act (Public Contract Code Sections 22000-22045). The Uniform Public Construction Cost Accounting Act has been incorporated as a part of the City of Lompoc Purchasing and Public Project Procedures (Chapter 26 of the Lompoc City Code).

On June 20, 2006, the City Council adopted the Plans and Specifications and awarded the contract in the amount of \$1,995,000.00 to Sansone Company, Inc., San Luis Obispo, California. At this time, the City Council also authorized the City Engineer to approve Contract Change Orders in an amount not to exceed \$300,000.00.

The Project was completed on October 3, 2008, for a final construction cost of \$2,190.600.70. Boyle Engineering provided construction inspection and contract administration assistance to City staff. City staff provided construction and consultant contract administration for this project. We have reviewed the completed project and have found it to be in conformance with the Contract Documents. Therefore, the Engineering Division recommends formal acceptance of the completed project by the City Council, and recordation of a Notice of Completion with the County of Santa Barbara.
