A Resolution Of The Council Of The City Of Lompoc,
County of Santa Barbara, State of California,
In the Matter of
Reciting the Facts of the Consolidated Presidential General Election
Held in Lompoc on November 4, 2008,
Declaring the Result thereof, and Other Matters as Provided by Law

WHEREAS, a Consolidated Presidential General Election was held and conducted in the City of Lompoc, California, on Tuesday, November 4, 2008, as required by law (the Election); and

WHEREAS, notice of the Election was given in time, form, and manner as provided by law; and that voting precincts were properly established; election officers were appointed; in all respects the Election was held and conducted, the votes were cast, received, and canvassed, and the returns made and declared in time, form, and manner as required by the provisions of the California Elections Code for the holding of elections in general law cities; and

WHEREAS, the County Clerk has canvassed the returns of the Election and provided the City with an Official Certification of Election Results of the Official Canvass and Certified Results, in accordance with Elections Code Section 15400.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF LOMPOC RESOLVES AS FOLLOWS:

SECTION 1. There were seventeen precincts established for the purpose of holding the Consolidated Presidential General Election.

SECTION 2. The Election was held for the purposes of electing the following officers of the City of Lompoc as required by applicable laws:

A Mayor of the City of Lompoc for a full term of two years;

Two members of the City Council for full terms of four years.

SECTION 3. The names of candidates for Mayor at the Election were as follows:

SECTION 4. The names of candidates at the Election for Member of the Council of the City of Lompoc were as follows:

DeWayne Holmdahl William "Will" Schuyler David Grill Cecilia Martner Bob Lingl Darrell Wade Tullis

SECTION 5. The number of votes given in the City to each of the above-named candidates were as listed on attached Exhibit "A."

SECTION 6. The City Council hereby determines and declares that:

Dick DeWees was elected as Mayor of the City of Lompoc for a full term of two years;

Cecilia Martner was elected as Member of the Council of the City of Lompoc for a full term of four years; and

Bob Lingl was elected as Member of the Council of the City of Lompoc for a full term of four years.

SECTION 7. The City Clerk shall enter on, the records of the City of Lompoc a statement of the Election results, showing:

- 1. The whole number of votes cast in the City of Lompoc;
- 2. The names of the candidates:
- 3. Each office sought by the candidates; and
- 4. The number of votes given in the City to each candidate.

SECTION 8. The City Clerk shall immediately make and deliver to the persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; the City Clerk shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have such persons subscribe thereto and file the same in the Office of the City Clerk; whereupon, each and all of the persons duly elected shall be inducted into the respective offices to which they have been elected.

SECTION 9. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions and shall note its passage in the minutes of the proceedings of the City Council meeting at which the Resolution is passed and adopted.
