# Regular Meeting of the Lompoc City Council and Lompoc Redevelopment Agency Tuesday, August 7, 2007 City Hall/100 Civic Center Plaza Council Chambers

#### **OPEN SESSION - 7:00 P.M. – Council Chambers**

#### **PRESENTATIONS PRESENTED ELSEWHERE:**

On July 25, 2007, at the Convalescent Care Center, Mayor DeWees presented a certificate of special recognition to Jean Workman for her 101<sup>st</sup> Birthday.

On July 26, 2007, at the Village Country Club, Mayor DeWees presented proclamations to Susan Warnstrom as Lompoc Valley Chamber of Commerce & Visitors Center 2007 Woman of the Year and to Bob Wyckoff as Lompoc Valley Chamber of Commerce & Visitors Center 2007 Man of the Year.

<u>CITY ADMINISTRATOR/EXECUTIVE DIRECTOR'S STATUS REPORT</u>: (distributed as an informational report).

#### **STAFF REQUESTS AND ANNOUNCEMENTS:**

City Administrator Gary Keefe summarized a letter received from the American Youth Soccer Organization (AYSO) requesting support from the Council and the public for much needed practice areas and space for storage of equipment. Mr. Keefe noted that Council/Agency Member Siminski called and requested from Council that his absences arising from his current illness be considered excused absences. *ACTION:* Motion/Second: <u>Holmdahl/Schuyler.</u> By a vote of 4 to 0, the Council granted the excused absences.

#### **COUNCIL/REDEVELOPMENT AGENCY REQUESTS AND ANNOUNCEMENTS:**

1. Parks and Recreation Director Dan McCaffrey presented an update on the Riverbend Park athletic fields. He stated completion is anticipated at the end of 2007 or the beginning of 2008.

Mayor/Chair DeWees stated he would like to see this project move forward and be completed when expected.

Council/Agency Member Holmdahl stated that Allan Hancock College is in the process of looking for sites for a new Police & Fire Academy, Lompoc campus being one of the potential sites. He would like to see the City have the ability to work with the College and offer any support that is needed. He commented on garage sale signs and would like Staff to add to the garage permits wording that signs are not permitted and that violators will be penalized. Staff stated that the Police Department has volunteers taking down these signs. Mr. Holmdahl acknowledged the dedication of the mural on the Alpha Club Building that took place in July.

Mayor DeWees expressed his concern with signs being posted by persons having yard sales and also by new home developers and asked Staff to contact them and advise them of the laws the City has regarding signs being posted. He acknowledged the Library's Jazz concerts on Sundays through the month of August and encouraged the public to attend. He congratulated the Lompoc Chamber of Commerce for the success of the Brushes and Blues event and congratulated the Kennel Club Show for their annual program. He expressed his wishes and well being to Councilmember Siminski and Don Willis.

Council/Agency Member Schuyler also commented on out-of-town businesses coming into town, having weekend sales and posting signs. He acknowledged the Lompoc Veteran's Council for a fundraiser that took place for the rehab of the Veterans Memorial Building.

#### **ORAL COMMUNICATIONS:**

1. Janice Keller commented on the potential site for a Police & Fire Academy at the Allan Hancock College Lompoc campus. She stated that if City property is involved, the matter must be agendized.

Councilmember Holmdahl stated that all necessary actions would be brought to Council for discussion.

Mayor DeWees announced that Dr. Joe Ortiz, President/Superintendent of Allan Hancock College, came to see him and stated that this is a matter of discussion with the College Board and that the College is not seeking any land.

10. A Request from Plains Exploration & Production Company (PXP), for Consideration of an Annexation of an Approximately 804-Acre Parcel to the City of Lompoc. The Project is known as the Purisima Hills Development and the Parcel is Approximately three (3) miles North of the Existing City Limits and West of Harris Grade Road (Assessor Parcel Number: 097-350-018, portion of 099-010-056, portion of 097-360-010) (Planning Division File No. Annexation No. 75).

Mayor DeWees announced a letter that was received by Cook Hill Properties asking that the item be continued due to Councilmember Siminski's absence and that Councilmember Siminski called and requested a continuance. He mentioned other letters received from Vandenberg Village Association, Ron Fink, Jamie Peters, Beverly Tootle, and Santa Barbara County Assistant Administrator.

11. Approved a \$285,000 Set-Aside Loan to Crown Laurel, LLC, to assist with the Construction of 11 Affordable Housing Units Located Within the Crown Laurel Housing Development (Northeast corner of Laurel Avenue and V Street), (APN 89-200-29)

Redevelopment Program Coordinator Linda Wertman presented the Staff report and recommendations.

Mike Rider, JM Development Counsel, spoke in support of Staff's recommendations.

By a 4 to 0 vote (Board Member Siminski *ABSENT*), the Board approved a \$285,000 Housing Set-Aside loan to Crown Laurel, LLC, to assist in the construction of 11 very low-, low- and moderate-income affordable housing units (for sale) and authorized the Executive Director or his designee to execute all documents required to execute the loan.
