## **RECOMMENDATION:**

It is recommended that the City Council adopt Resolution No. 5304(06) which authorizes the Mayor to execute Cooperative Agreement #05-CA-0182 for installation of traffic control signals and safety lighting on State Route 1 (Ocean Avenue) at Third Street.

The Resolution authorizes the City Clerk to attach a certified copy of the Resolution to the original and to each of four copies of each Agreement and to forward all documentation to the State of California for processing.

## DISCUSSION:

The Department of Transportation has determined that warrants for signalization have been met for the intersection of State Route 1 (Ocean Avenue) and Third Street.

Attached for execution by the Mayor are the original and four (4) copies of the Cooperative Agreement between the State and the City of Lompoc for the installation of traffic control signals and safety lighting on State Route 1 and Third Street.

Total estimated project cost is \$170,000. Under the agreement, the State will perform all work and pay 53% of the total project costs, including State-furnished materials, and the City will pay 47% of the total project costs. Federal-aid funding amounting to \$72,000 has been approved for ninety percent (90%) of the City's total project costs.

In the event bids received are up to ten percent (10%) over the construction estimate, the City's total cost would be \$86,050. Under the Agreement, the City's total obligation shall not exceed \$86,050 without written authorization.

Total estimated project cost is \$170,000. Under the Agreement, the City's total obligation shall not exceed \$86,050 without written authorization. Federal-aid funding has been approved for ninety percent (90%) of the City's total not to exceed obligation. City's ten percent (10%) match will be financed from already collected Traffic Signal Impact Fees in the Street Development Fund.
