SUBJECT: FINAL ACCEPTANCE OF PROJECT NO. FY-01-WW-1,

SANITARY SEWER IMPROVEMENTS -

COLLEGE AVENUE, "U" STREET, AND THIRD STREET

RECOMMENDATION:

Staff recommends that the City Council:

- A) Accept Project No. FY-01-WW-1 as complete.
- B) Instruct the City Clerk to file the required Notice of Completion regarding this project.

BACKGROUND:

The City Council appropriated a total of \$2,784,000 for major sewer system repairs, improvements and replacements in the 1999-2001 and 2001-2003 Wastewater Division Budget. These appropriations included \$1,353,000 for trunk sewers in College Ave., from Third St. to Wilson (Miguelito) Channel, \$603,000 to replace an aging sewage lift (pump) station located at Third St. and Maple Ave., and \$828,000 to replace a sewer main in "U" St., from Olive Ave. to Ocean Ave., including a siphon under Wilson (Miguelito) Channel.

On October 1, 2002, the City Council awarded Boyle Engineering Corporation \$481,000 for the design of these projects. Plans for the Sanitary Sewer Improvements were reviewed and approved by the Wastewater and Engineering Divisions.

ACCEPTANCE OF PROJECT NO. FY-01-WW-1 Sanitary Sewer Improvements Page -2-

The Project was noticed, advertised and bid in accordance with the procedures of the Uniform Public Construction Cost Accounting Act (Public Contract Code Sections 22000-22045). The Uniform Public Construction Cost Accounting Act has been incorporated as a part of the City of Lompoc Purchasing and Public Project Procedures (Chapter 26 of the Lompoc City Code). On June 1, 2004, the City Council adopted the Plans and Specifications and awarded the contract in the amount of \$2,094,950.00 to R. Baker, Inc., Oceano, CA. At this time, the City Council also authorized the City Engineer to approve Contract Change Orders in an amount not to exceed \$400,000.00. The Project was completed on April 29, 2005, for the final construction cost of \$2,312,579.68.

City staff provided construction-engineering services for this project. We have reviewed the completed project and found it to be in conformance with the Contract Documents. Therefore, the Engineering Division recommends formal acceptance of the completed project by the City Council, and recordation of a Notice of Completion with the County of Santa Barbara.


