Lompoc Hospital District Administrator James Raggio, presented a PowerPoint presentation on the selected sites for the new Hospital and requested Council cooperation to expedite construction and solve parking issues.

- 3. Received the Fiscal-Year 2004-2005 Consolidated Annual Performance and Evaluation Report (CAPER) and directed the Community Development Department to file said report with the U.S. Department of Housing and Urban Development (HUD). (Councilmember Keller voted NO).
- 4. Award of Project No. FY-05-B-4, Residential Demolition, 211 South "I" Street, Lompoc, CA. (Councilmember Keller requested this item be considered at the end of the meeting.)
- 5. Rejected all bids for Project No. FY-00-SD-1 in accordance with Paragraph 10, Page 1, "Notice To Contractors," of the Project Manual, Part A, and Lompoc City Code Section 2636.
- 6. Adopted the Specifications for Project No. FY-05-AP-1, as required by Section 22039 of the Public Contract Code, (copies of specs are on file in the City Engineer's Office); awarded the Contract in the amount of \$200,983.00 to ET Energy, a division of ET Environmental Corp., LLC; authorized the Mayor to execute the necessary agreements for this Project; authorized the City Engineer to approve Contract Change Orders in an amount not to exceed \$35,000.00; and appropriate funds accordingly.
- 7. Adopted Resolution No. 5287(05) approving the Investment Policy for the City of Lompoc.
- 8. Reviewed the Summary of Resolutions to be considered at the Annual League of California Cities Conference during the Annual Business Meeting on October 8, 2005, in San Francisco.
- 9. Authorized the Mayor to sign an agreement to terminate the Long Term Ground Lease Agreement for Hangar Construction and Aircraft Storage with La Purisima Air, LLC.

10. Appointment of Council Representative as Voting Delegate and Alternate Delegate for 2005 League of California Cities Annual Conference, October 6-8, San Francisco, California.

# **Public Comment:**

1. Alberto Quillo spoke on Historical Preservation issues.

Councilmember Keller requested that any workshop or study session be noticed in Spanish and English and that an interpreter be present at the sessions.

Mayor DeWees spoke in support of staff's recommendations.

Ms. McAvoy recommended that the City of Lompoc update the Landmarks Ordinance, adopt a Historic Preservation District Ordinance with incentives attached, and educate staff and officials regarding preservation and zoning.

Councilmember Schuyler suggested Council have study sessions before the regular Council meetings to meet with the public and staff to discuss items on the Agenda.

Councilmember Holmdahl spoke in support of staff's recommendations and commented on Councilmember Schuyler's suggestion.

<u>ACTION:</u> Motion/Second: Holmdahl/Schuyler. By a unanimous vote, the City Council received the *Historic Resources and Planning Analysis Study* prepared by Historic Resources Group, dated July 2005; directed staff to meet with the Lompoc Valley Historical Society for their input and feedback; and conduct a Study Session on the findings and recommendations in the report; and return the item to the City Council with a recommendation based upon the above actions.

#### 12. Appropriation of Supplemental Law Enforcement Services Fund – AB 3229.

Police Captain Tim Dabney presented the staff report and recommendations.

#### **Public Comment:**

1. Alberto Quillo requested the monies be spent towards public safety.

Mayor DeWees explained that the monies are strictly for law enforcement.

2. Ralph Harman spoke in support of staff's recommendations.

<u>ACTION:</u> Motion/Second: Keller/Siminski. By a unanimous vote, the City Council approved the request for funding from the *Supplemental Law Enforcement Services Fund* – "AB 3229" for fiscal year 2005-2006 pursuant to Government Code 30061.

By a unanimous vote, the City Council adopted the Specifications for Project No. FY-05-B-4, as required by Section 22039 of the Public Contract Code, (copies of specs are on file in the City Engineer's Office; awarded the contract in the amount of \$78,000.00 to All Contractors, Inc.; authorized the Mayor to execute the necessary agreements for this Project; authorized the City Engineer to approve Contract Change Orders in an amount not to exceed \$15,000.00; and approved City-paid support of the demolition pre-bid, inspection, and contract administration effort, estimated to cost \$13,400.

Councilmember Siminski announced that the Northern California Power Agency conference is funded through the electric fund and not the general fund.
