## 1. PHASE 2 -- COMPREHENSIVE 2030 GENERAL PLAN UPDATE

Planning Commission consideration of recommendations to the City Council on the Comprehensive 2030 General Plan Update:

- Discussion of City Council requested amendments to the Land Use Element;
- Review of the draft Housing Element;
- Revisions to the Conservation/Open Space, Parks & Recreation, Urban Design, Noise, Safety, Public Services, Economic Development Elements: and
- Review of the draft Addendum to the Final Environmental Impact Report (FEIR 09-01) prepared for the 2030 General Plan Update and certified by the City Council.

The Planning Commission will consider recommendations to the City Council on the above noted items. Due to the volume of material to be considered, discussion may be continued to the August 13 regular meeting and resolutions will be presented for consideration at the August 27, 2014 special meeting.

Commissioner Fink advised the audience the Planning Commission will receive a staff report on each section of the material, have discussion, take public testimony, and accept or direct staff to change the proposed material for final recommendation to the City Council.

Planning Manager Lucille Breese advised the Commission that at the March 18, 2014 meeting, the City Council had made requests for Planning Commission consideration.

1) Change Mixed Use title to Urban Commercial or other suitable name.

Commissioner Rodenhi noted the term *Mixed Use* seems fairly common and is descriptive of the district.

Commissioner Leach indicated Mixed Use is more descriptive than Urban Commercial and provides options to the developer.

Commissioner Cioni asked about the rationale for the requested change.

Councilmember Starbuck stated at the City Council meeting the Board of Realtors representatives discussed difficulty with financing Mixed Use projects.

The Commission discussed the request and determined the appropriate time to consider changing the name would be during the upcoming Zoning Ordinance update.

MOTION: It was moved by Commissioner Fink, seconded by Commissioner Cioni

> that the change of Mixed Use title to Urban Commercial not be recommended at this time but instead be considered during the upcoming

Zoning Ordinance update.

VOTE: The motion passed on a voice vote of 4-0-1, with Commissioner Clark

absent.

2) Include additional language supporting healthy lifestyles to the Land Use Element, specifically:

Modify Goal 2, Policy 2.4: The City should encourage creative and efficient site designs in residential developments which address natural constraints, promote energy efficiency, overall sustainability, walkability, and bikeability, protect aesthetic qualities, maintain neighborhood character, and improve public health.

 Add new policy (Goal 3, Policy 3.9): The City shall encourage all new commercial development designs to promote walkability.

Add new policy (Goal 4, Policy 4.7): The City shall encourage new common facilities to support walkable and/or bikeable design.

The Commission noted there was language in the Land Use Element and the additional language was acceptable.

MOTION: It was moved by Commissioner Fink, seconded by Commissioner Leach

that the modifications to the Land Use Element text be included.

VOTE: The motion passed on a voice vote of 4-0-1, with Commissioner Clark

absent.

Ms. Breese introduced Mr. Gary Kaiser of Rincon Consultants who presented the power point summarizing the staff report. Mr. Kaiser advised the Commission that the Housing Element was not available for review this evening but would be presented at a future meeting; he noted the Housing Element is a very technical document that must be coordinated with and accepted by the State.

MOTION: It was moved by Commissioner Fink, seconded by Commissioner Leach

that review of the Housing Element be continued to a future date.

VOTE:

The motion passed on a voice vote of 4-0-1, with Commissioner Clark absent.

Mr. Kaiser provided a Power Point presentation of the documents being considered:

Commissioner Fink noted Table PR1 – 18 acre park should be removed from the table.

a decision but staff indicated the PC recommendation not to change the MU designation at this time would be conveyed to the Council in the staff report and verbally.

that the Commission adopt Resolution No. 772(14) based upon the findings

of fact in the Resolution.

**VOTE:** The motion passed on a 4-0-1 vote, with Commissioner Cioni absent.

Mr. Kaiser informed the Commission the Economic Development Element is currently being reviewed by the Economic Development Committee and will be presented at a future date.
