Planning Commission meetings may be canceled for lack of quorum or business. Planning Commission agendas are posted at City Hall 72 hours prior to the public meeting. The Development Review Board (DRB) meets on Tuesday on an as-needed basis. Applicants and their representatives may attend the DRB meetings. The City Council meets on the 1st and 3rd Tuesday of each month at 7:00 p.m. at City Hall. The City Council will consider General Plan Amendments in March, June, September and December.
