PUBLIC HEARING ITEMS:

LOM 571 -Time Extension for the Burton Ranch Vesting Tentative Subdivision Map

A request for Planning Commission consideration of a two-year time extension submitted by John Martin, representing property owner Harris Grade Partners and the Towbes Group, Inc., to extend LOM 571 for the Burton Ranch Vesting Tentative Subdivision Map to subdivide an approximately 32.6-acre site into 65 parcels. The proposed project site is located north of the intersection of Harris Grade Road and Highway 1 (Assessor Parcel Numbers: 097-250-040 and 097-250-013) within the Burton Ranch Specific Plan. This action is categorically exempt pursuant to Section 65457of the California Environmental Quality Act (CEQA) as the proposal is consistent with the adopted Burton Ranch Specific Plan for which a Program Environmental Impact Report (SCH#2002091045) was previously certified. An addendum for the time extension has been prepared pursuant to the California Environmental Quality Act (CEQA).

Assistant Planner Cody Graybehl summarized the written staff report.

<u>Jon Martin, Harris Grade Partners,</u> Burton Ranch has Development Agreement (DA) with Mission Hills Community Services District that has expired, we are working on a number of possible resolutions. We are hoping to begin construction before 2020.

Commissioner Gonzales inquired on price levels.

Jon Martin, Harris Grade Partners, stated that conditions are good and if not for infrastructure issues would probably be building.

Commissioner Rodenhi asked why Burton Ranch will not be using the City of Lompoc for water and sewer needs.

Jon Martin, Harris Grade Partners, due to the terms of the annexation agreement.

Commissioner Leach asked if Mission Hills Community Service District has the capacity to service the Burton Ranch area.

Jon Martin, Harris Grade Partners, possibly, the MHCSD is looking to expand their facility and would like funding from Burton Ranch and help with well water production.
