### **AMENDMENT NO. 1 to**

## **MEMORANDUM OF UNDERSTANDING FOR BREEZE ROUTE 100**

# BETWEEN THE CITIES OF SANTA MARIA, LOMPOC, THE COUNTY OF SANTA BARBARA AND THE SANTA BARBARA COUNTY ASSOCIATION OF GOVERNMENTS

This Amendment No. 1 ("Amendment") to the Memorandum of Understanding, dated July 1, 2014 ("MOU"), by and between the City of Santa Maria, City of Lompoc, County of Santa Barbara, and Santa Barbara County Association of Governments ("SBCAG"), collectively referred to as "the Parties," for the funding and operation of the transit service known as the "Breeze," is hereby agreed to by the Parties, and shall be effective on July 1, 2019.

A. Section 1 of the MOU is amended as follows (additions in <u>underline</u>, deletions in <u>strikethrough</u>):

# 1. Project Description

The Breeze Route 100 Continuation Project ("PROJECT") will provide regularly scheduled, fixed-route, intercity bus service between Santa Maria and Lompoc. The PROJECT will be open to the public, for all trip purposes, and will be fully accessible to persons with disabilities. Santa Maria in coordination with Lompoc and the County will operate the service. The service will continue approximately sixty months (60), commencing on July 1, 2014 or on the date when all PARTIES have signed the MOU, whichever occurs later, and remaining in effect until June 30, 2019, contingent on the availability of funding. The service will commence on July 1, 2014 or on the date when all PARTIES have signed the MOU, whichever occurs later, and will remain in effect until June 30, 2020, contingent on the availability of funding.

- B. This Amendment may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.
- C. In all other respects, the MOU shall remain unchanged and in full force and effect.
