PUBLIC HEARING ITEM:

Two Year Time Extension for the Transit Operation/Fleet Maintenance Facility Tentative Parcel Map (LOM 601)

A request for Planning Commission consideration of a two year time extension submitted by Michael Luther representing the City of Lompoc for the Transit Operation/Fleet Maintenance Facility Tentative Parcel Map to combine seven (7) lots into three (3) lots. The property is located in the Industrial Zoning District at the northeast corner of Chestnut Avenue and D Street (Assessor Parcel Numbers: 085-033-001, -004, -005, -006, -007 and 085-040-001, -002, and a portion of the abandoned area of C Street). A Mitigated Negative Declaration (SCH# 2017051010) for the Tentative Parcel Map was prepared and an Addendum pursuant to the California Environmental Quality Act (CEQA).

Commissioner Gonzales noted that he had a conflict of interest and stepped down from the dais.

Associate Planner Cody Graybehl summarized the written staff report with a PowerPoint presentation.

City of Lompoc Senior Engineer Christos Stoyos stated they are requesting a time extension to allow for additional civil design review of the project before moving forward.
