

**RESOLUTION NO. 6273(19)**

**A Resolution of the Council of the City of Lompoc,  
County of Santa Barbara, State of California,  
Approval of the Fiscal Year 2019-20 Budgets for  
CDBG and Human Services Funds,  
Supplemental Appropriations, and Necessary Certifications  
and Authorizations Required by HUD**

**WHEREAS**, the Housing and Community Development Act of 1974, as amended, provides for assistance to local government to develop programs which create viable urban communities; and

**WHEREAS**, the City of Lompoc (City) received notification from the U.S. Department of Housing and Urban Development (HUD) of the Fiscal Year (FY) 2019-20 allocations for Office of Community Planning and Development's (CPD) formula programs, which provide funding for housing, community and economic development activities, and assistance for low- and moderate-income persons and special populations across the country; and

**WHEREAS**, the City's FY 2019-20 Community Development Block Grant (CDBG) available amount is \$475,399; and

**WHEREAS**, a 30-day public review and comment period (July 10, 2019 – August 8, 2019) was noticed to the public in the Lompoc Record newspaper on June 10, 2019, and

**WHEREAS**, a public hearing was held on August 6, 2019, to obtain public comments and proposals for inclusion in the FY 2019-20 Lompoc Annual Action Plan; and

**WHEREAS**, at its meeting of August 6, 2019, the City Council took public testimony on the Draft FY 2019-20 Lompoc Annual Action Plan.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The Lompoc FY 2019-20 CDBG Budget (Summary Budget is attached hereto as Exhibit "A") is hereby adopted.

**SECTION 2.** The Lompoc FY 2019-20 supplemental appropriations (Line Item Budget attached hereto as Exhibit "B") is hereby adopted.

**SECTION 3.** To comply with requirements of the FY 2019-20 Annual Action Plan and to properly administer the CDBG and Human Service funds on behalf of the City, the City

Manager, or designee, are hereby authorized to execute all necessary agreements, documents, and certifications (including, but not limited to, loan documents, demand statements, default notices, foreclosure actions, reconveyances, subordinations, loan workouts, assumptions, promissory notes, deeds of trust, escrow documents, Request for Release of Funds Form #HUD-7015.15, federal environmental review documents, and Section 108 loan documents).

**SECTION 4. Effective Date.** This Resolution is effective on the day of its adoption.
