



**BUILDING ENERGY USE DATA AND PUBLIC DISCLOSURE PROGRAM
CUSTOMER ENERGY USE DATA RELEASE FORM**

This form is made available to allow authorized parties (“Owner” or “Owner’s Agent/ representative”, hereinafter referred to individually or collectively as “Owner”) to participate in and acquire the energy use data for a "covered building", in compliance with the Building Energy Use Data and Public Disclosure Program ("Program"), as defined within Title 20, Division 2, Chapter 4, Article 9, Sections 1680-1685 of the California Code of Regulations.

Pursuant to the Program, the Owner of your building has requested from the City of Lompoc the energy use data of the tenants and occupants of your building, in order to comply with the Program’s energy reporting requirements.

All definitions, terms and conditions of the Program are hereby incorporated to and made part of this Proof of Ownership form by reference.

All parties are bound to the data request practices and protocols of City of Lompoc (“Utility”) and will perform best efforts to comply with all specified energy usage data request requirements.

Utility is required to provide aggregated historic energy use data for all accounts, meters and services in certain covered buildings. Such Customer-specific energy use data can be deemed proprietary and confidential.

The customer, tenant or occupant, hereinafter referred to individually or collectively as “Customer”, of any portion of a covered building (or buildings) for which energy usage data is being requested by the Owner to meet the Program compliance requirements has the right and discretion to release their specific energy use data to the Owner.

If you wish to share your energy use data with the Owner of your building, please indicate so by signing this form below.

I, the undersigned, do hereby authorize City of Lompoc to release and deliver the historic energy use data, for the utility service accounts listed on the attached form, to the Owner of the associated Building(s), as required for participation in the Building Energy Use Data and Public Disclosure Program. This this data release consent form will remain active in perpetuity until withdrawn in writing by myself or my designee, or until I vacate the associated property or facility.
