REPORT ON ACTION TAKEN DURING CLOSED SESSION:

City Attorney Jeff Malawy stated no reportable action was taken during the Closed Session.

Mayor Jenelle Osborne led the Pledge of Allegiance.

CITY MANAGER REPORT: (Information only)

City Manager Jim Throop announced the Rancho Purisima Chapter of the Daughters of the American Revolution have completed the restoration of the World War I monument at the Lompoc Museum and is inviting the public to the rededication ceremony to be held on Saturday, September 7, 2019, at 11am at the Museum; stated the Lompoc Aquatic Center re-opened after the 11 day closure that allowed Staff to perform needed preventative maintenance on the facility; and reported Purisima Hills also known as Summit View Homes, has submitted plans to the City for the first few homes in the new development on Purisima Road and Harris Grade Road, Lompoc.

Council Member Mosby asked Staff to attach the letter from the City to the Santa Barbara County Long Range Planning Division, regarding the City's annexation application, to this Agenda on the City's website.

STAFF PRESENTATIONS/ANNOUNCEMENTS/REQUESTS:

Safety Officer Jo Cavanaugh presented the list of the **Above & Beyond Awards** for the Fourth Quarter of the 2018-2019 Year.

Library Director Sarah Bleyl gave a presentation highlighting the Lompoc Library's **Summer Reading Program** and September 2019 **Library Sign-up Month**.

ORAL COMMUNICATIONS (3 Minutes Maximum):

- 1. Deb Andrews expressed her gratitude to Council for listening to the Citizens and then requested the Council bring back the invocation.
- 2. Michael Baker, CEO of the United Boys & Girls Club of Santa Barbara County, spoke about the Lompoc Club and reminded everyone of the scholarships available to any child who wishes to join the Club, and thanked Council for their continued support of these programs.
- 3. John Linn offered to provide help with the invocation.

Council Member Cordova stepped down from the dais and exited the Council Chamber.

City Attorney Jeff Malawy stated this property is within 500ft of property owned by Council Member Mosby, but does not cause a conflict of interest because no financial gains or losses to Council Member Mosby's property could be realized by the any decision on this matter.

PUBLIC HEARING:

3. Decision and Direction Regarding the Appeal by the Lompoc Artificial Kidney Center, LLC, of Waste Discharge Permit I-0013 and Utility Director's Revised and Reissued Ruling on Request for Reconsideration in Accordance with Lompoc Municipal Code Sections 1.32.010 and 13.16.130.

Utilities Director Brad Wilkie presented the Staff report and recommendations, and reminded everyone this item is for Council to decide if the business is required to process a wastewater permit as an industrial user.

Council Member Starbuck asked if a code violation complaint was filed against this business by a citizen or by City Staff and if the City is working to limit the amount of salt outside agencies, specifically the Vandenberg Village Community Service District, are allowing to flow into the City's water. Utilities Director Brad Wilkie stated the City received a signed complaint from a citizen; and explained the City is working with outside service districts to ensure the water sent to the City's water treatment plant is from those districts, is in accordance of the requirements of the City's permit.

Representatives from the Lompoc Artificial Kidney Center, LLC, Ian Gutherie and Dr. Thomas Allyn presented a Power Point Presentation and requested the Council uphold the appeal.

Public Comment:

- 1. John Linn stated he believes the Lompoc Artificial Kidney Center, should be considered a residential user of wastewater and provided a handout of unaudited information regarding the City's water quality.
- 2. (Name not Given), spoke in favor of allowing the Lompoc Artificial Kidney Center and expressed her gratitude for how the Center has helped her to continue to live a fulfilling life.
- 3. Marlene (Last Name Not Given), spoke the quality of care provided at the Lompoc Artificial Kidney Center and large number of patients who receive dialysis care in this facility.
- 4. Kim Coy spoke about the importance of a dialysis center and how her family has benefitted from quality dialysis care given to her own mother.

Council discussed this matter at great length.

At 8:12 P.M. Mayor Osborne called a brief recess. At 8:22 P.M. the meeting was called back in session with all Council Members present, excluding Council Member Cordova.

Council continued the discussion.

<u>ACTION</u>: Motion/Second: <u>Vega/Starbuck</u>. By a 4-0-1 vote (Council Member Cordova was absent), Council Stay the appeal; and directed Staff to return at a future date with a City Ordinance to amend the LMC to allow the following: use of water softeners for industrial use with an efficiency rating of no less than 4,000 grains of hardness removed per pound of salt used in regeneration, subject to compliance with salt limitations for all operations; redefine hazardous waste to exclude dialysate (waste from dialysis operations); include a change to domestic discharge to include dialysate; amend definition of industrial waste to state does not include anything defined as domestic wastewater; and seek formal approval from the Regional Water Quality Control Board for the foregoing amendments to the City of Lompoc Municipal Code.

COUNCIL COMMENTS AND MEETING REPORTS:

Council Member Mosby requested Staff draft a letter to the California Fish & Wildlife requesting public access and fishing in the marine preserve at Surf Beach and draft a letter to the County of Santa Barbara requesting the lagoon at Ocean Park be re-opened for public recreation and return at future date for Council's review; and asked Staff to draft regulations regarding needle exchange and or give away programs inside the City. All requests were seconded by Council Member Vega and carried by Council Member Starbuck.

Mayor Osborne stated she attended several events, including the Lompoc Chamber of Commerce and Visitor's Bureau Annual Dinner, and the Lompoc Youth Football League opening ceremonies; reminded the public of the upcoming WWI Memorial Re-dedication ceremony happening on September 7, 2019 at the Lompoc Museum and requested Staff return at a future meeting with a Staff report on the discussion of hiring a consultant to help review and evaluate the City's municipal code and ordinances regarding wastewater. The request was seconded by Council Member Mosby and carried by Council Member Starbuck.
