REPORT ON ACTION TAKEN DURING CLOSED SESSION:

City Attorney Jeff Malawy stated no reportable action was taken during the Closed Session.

Morris Sobhani gave the invocation and Mayor Jenelle Osborne led the **Pledge of Allegiance**.

PUBLIC COMMENT ON CONSENT CALENDAR ITEMS (Max of 3 Minutes): None

CONSENT CALENDAR:

City Attorney Jeff Malawy requested Consent Calendar Item No. 5 be removed from the Consent Calendar.

Council Member Mosby requested Section 3 of Resolution No. 6270(19) of Consent Calendar Item No. 3, be read into the record.

City Clerk Stacey Haddon read the following verbiage out loud:

SECTION 3. The City Council's determination is based on the following findings:

- (a) The record does not contain any evidence demonstrating that (Vitamin and Herb Store) VHS produces liquid waste containing an excessive amount of fat, oil, or grease.
- (b) VHS's only food production is the production of a small number of salads, sandwiches, and smoothies.
- (c) The record does not contain any evidence that VHS has experienced sewer pipe blockages in the past, whether from excessive grease or from any other cause.
- (d) The record does not contain any evidence that VHS's operations have ever resulted in wastewater contamination.
- (e) Consequently, the record does not contain sufficient evidence to demonstrate that the installation of a grease trap or interceptor at VHS is "necessary for the protection of the wastewater system from liquid wastes containing excessive amounts of grease." (LMC 13.16.370(A).)

ACTION: Motion/Second: Starbuck/Vega. By a 5-0 vote, Council:

- 1. Approved the Minutes of the Lompoc City Council Special Meeting of June 24, 2019
- 2. Approve Prepayment of the Fiscal Year 2019-20 Annual Unfunded Actuarial Liability for the Miscellaneous and Safety California Public Employees' Retirement System Plans.

Approved the prepayment to California Public Employees' Retirement System (CalPERS) of the Fiscal Year (FY) 2019-20 annual portion of the City's Unfunded Actuarial Liability (UAL) for each plan in the total amount of \$5,616,641 (a 3.5% discount realizing a benefit to the City of \$200,042 compared with the total payments of \$5,816,683, if the prepayment being recommended were not made) and authorize the payment of the FY 2019-20 portion of the UAL by July 31, 2019.

3. Adoption of Resolution No. 6270(19), Upholding the Appeal by Vitamin and Herb Store (located at 525 W Central Avenue) of the Utility Director's Ruling on Request for Reconsideration Regarding Enforcement of Lompoc Municipal Code Section 13.16.370.

4. Adoption of Resolution No. 6271(19) Ordering the Levy of Special Taxes for Fiscal Year 2019-20 Within Community Facilities District No. 2018-01 (Summit View Homes).

Adopted Resolution No. 6271(19), ordering the levy of special taxes for Fiscal Year (FY) 2019-20 within Community Facilities District No. 2018-01 (Summit View Homes).

Item No. 5 was removed from the Consent Calendar to allow City Attorney Jeff Malawy clearly state Staff recommendations and avoid any confusion, stating he thought the Agenda title was a bit vague. The recommendations should be: to adopt Resolution No. 6259(19), introduce Ordinance No. 1665(19), through first reading only with further reading waived, and make findings related to the EIR Addendum prepared pursuant to the California Environmental Quality Act, and already contained in Resolution No. 6259(19) and Ordinance No. 1665(19).

5. Adopt Resolution No. 6259(19) to:

- Change the General Plan map designation of one parcel (APN: 085-150-089) at the northwest corner of Seventh Street and Cypress Avenue from Office Commercial (OC) to Mixed Use (MU); and
- ii. Change the General Plan map designation of a portion of one parcel (APN: 085-150-090) at the southwest corner of Seventh Street and Ocean Avenue from OC to to Mixed Use (MU); and

Introduce through first reading by title only with further reading waived, Ordinance No. 1665(19), which will:

- Change the Zoning Map designation for one parcel (APN: 085-150-089) at the northwest corner of Seventh Street and Cypress Avenue from Commercial Office (CO) to Mixed Use (MU); and
- ii. Change the Zoning Map designation of a portion of one parcel (APN: 085-150-090) at the southwest corner of Seventh Street and Ocean Avenue from CO to to Mixed Use (MU).

<u>ACTION</u>: Motion/Second: <u>Starbuck/Vega</u>. By a 4-1 vote (Council Member Cordova voted No), Council adopted Resolution No. 6259(19), introduced Ordinance No. 1665(19), through first reading only with further reading waived make findings related to the EIR Addendum prepared pursuant to the California Environmental Quality Act, contained in Resolution No. 6259(19) and Ordinance No. 1665(19).

STAFF PRESENTATIONS/ANNOUNCEMENTS/REQUESTS:

- Utility Director Brad Wilkie introduced newly hired Administrative Analyst Kristin Worthly and Utility Conservation Representative Frances Gonzales.
- Electric Utility Manager Tikan Singh gave an update on the impact of Pacific Gas & Electric's Public Safety Power Shutoff program to the City of Lompoc.

Council thanked Staff for the information presented and suggested the City look into obtaining a backup generators for the City's radio station and providing this information to citizens with a mailer inserted into utility bills and provide tips on what to do if an power shutdown happens.

Electric Utility Manager Tikan Singh stated the Electric Division is offering to pay for the building permit for residential or business customers who install a generator to their property. Council Member Mosby requested Staff return at a later date with a report for discussion and action on allowing the Electric Division to pay for building permit for residential or business customers who install a generator to their property. The request was seconded by Council Member Vega, but died without a third and carrying vote.

Mayor Osborne asked Staff to provide Council with an update if a large number of building permits are issued for the installation of generators.

- 3. Juan (Unknown last name), requested Council not sign the Memorandum of Understanding with Pale Blue Dot Ventures, LLC.

- 4. Don Smith asked if the City is able to connect to the power station located on Vandenberg Air Force Base.
- 5. Sue Coupland spoke about fundraising events she and Eva Blaisdell of Lady Rocket Enterprises, and asked the Council to delay signing the Memorandum of Understanding with Pale Blue Dot Ventures, LLC.

APPOINTMENTS:

6. Council Appointment of City of Lompoc Administrative Analyst Kristin Worthley as Alternate Representative for the Western Area of the Santa Ynez River Valley Groundwater Basin.

ACTION: Motion/Second: <u>Starbuck/Cordova</u>. By a 5-0 vote, Council appointed Kristin Worthley as Alternate Representative for the Western Area of the Santa Ynez River Valley Groundwater Basin.

NEW BUSINESS:

7. Approval of a Memorandum of Understanding with Pale Blue Dot Ventures, LLC, for Potential Sale of Approximately 82 acres of Cityowned Property, Including and Adjacent to Ken Adam Park, for Development of a Space Center.

City Attorney Jeff Malawy presented the Staff report and recommendations and introduced Steve Franke and Bob Allen from Pale Blue Dot Ventures, LLC. Mr. Franke and Allen provided a power point presentation regarding this proposed project.

Public Comment:

- 1. Keith Fiekert, Susan Gallacher, Patricia Fresh, Mark Ashamalla, Joe Garcia, and John Linn spoke in favor of Council signing the Memorandum of Understanding with Pale Blue Dot Ventures, LLC.
- 2. Will Schuyler stated this proposed project has great interest, but he has concerns about what part of the land will be sold.
- 3. Darrell Tullis expressed his desire to ensure this project is beneficial to local area youth and this provides real educational opportunities.

<u>ACTION</u>: Motion/Second: <u>Mosby/Cordova</u>. By a 5-0 vote Council approved the Memorandum of Understanding with Pale Blue Dot Ventures, LLC to explore the potential sale of the approximately 82 acres of City-owned property next to and including Ken Adam Park for the development of space center facilities.
