#### **REPORT ON ACTION TAKEN DURING CLOSED SESSION:**

City Attorney Jeff Malawy reported the Council discussed both items listed on the Closed Session Agenda, but no reportable action was taken.

City Manager Jim Throop stated there was nothing to be reported.

Council Member Mosby asked for Staff to confirm the City is not in danger of turning off or closing its water plant even if Measure I2020 is not passed by the voters on March 3, 2020. City Manager Jim Throop stated City Staff has provided educational pamphlets and presentations for Measure I2020 and assured everyone the City is not closing its electric or water services.

## PUBLIC COMMENT ON CONSENT CALENDAR ITEMS (Max of 3 Minutes): None

Council Member Mosby recused himself from participating in the vote for Consent Item No. 3, stating he owns real property within 500 feet of the subject property.

Council Member Vega asked for confirmation of the Council's previous action regarding the requested changes to the meeting dates for the Public Safety Commission. Mayor Osborne explained the Council approved to move forward with the Public Safety Commission's request for additional meetings and directed that Commission to return to Council at a later date with suggestions on reducing costs to City for holding monthly meetings of the Public Safety Commission.

#### **NEW BUSINESS:**

5. Adoption of Resolution No. 6304(20); Policy on the Procedure for the Discontinuance of Residential Water Service for Delinquent Accounts or Other Circumstances.

Financial Services Manager Melinda Wall presented the Staff report and recommendations.

Mayor Osborne reported she participated in the **Point in Time Count**; was invited to attend the Installation of Officers Ceremony for the Lompoc International Order of Odd Fellows; attended the retirement party for City of Lompoc Fire Battalion Chiefs Mark Bray and Chuck Ruda and the Lompoc Peace Prize event where Yasmine Dawson was awarded the Peace Prize; congratulated all participants and winners of the American Association University of Women's Speech Trek; and announced she was appointed to the League of California Cities Transportation, Communications, and Public Works Policy Committee
