

**RESOLUTION NO. 6356(20)**

**A Resolution of the City Council of the City of Lompoc,  
County of Santa Barbara, State of California,  
Approving Supplemental Appropriations and Supplemental  
Revenues for Project No. FY-20-S-2,  
2020 Cape Seal Project**

**WHEREAS**, the City Council of the City of Lompoc (City) approved appropriations for Project No. FY-20-S-2, 2020 Cape Seal Project (Project) as part of the Biennial Budget Fiscal Years 2019-21 on June 24, 2019; and

**WHEREAS**, the City has implemented an ongoing capital project street rehabilitation program (Program) in order to replace failed street pavement and resurface City streets to promote safety and mobility for the greatest number of users as efficiently as possible, limited in scope to available road funding resources; and

**WHEREAS**, as part of the Program, the City has developed Project No. FY-20-S-2, 2020 Cape Seal Project (Project), to restore the pavement surface of various City streets and alleys; and

**WHEREAS**, the street pavement rehabilitation proposed by the Project cost-efficiently surfaces and seals the underlying pavement in order to protect it from various damaging elements, provide a new wearing surface, and lengthen the pavement service life; and

**WHEREAS**, the City applied for, and was awarded, a State of California grant from CalRecycle to fund \$1 per square yard of rubber chip seal, which is proposed to fund \$155,000 of Project chip seal construction; and

**WHEREAS**, the City Council desires to complete Project by appropriating CalRecycle State grant funds.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** To approve budget appropriations for the Project approved at the August 4, 2020, City Council meeting as follows:
