A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Adopting the Appropriations for the Caltrans Streetscape Multi-Modal Improvement Plan Project (Project No. GR 18-01)

**WHEREAS**, on June 24, 2019, the City Council of the City of Lompoc (City) approved and adopted the Biennial Budget Fiscal Years 2019-2021; and

WHEREAS, the City, on November 20, 2018, was authorized by the City Council as adopted in Resolution No. 6228(18) to apply for the California Department of Transportation (Caltrans) Sustainable Communities Competitive Grant (Caltrans Grant) in order to design a Multi-modal Improvement Streetscape Plan (Project) along Highways 1 and 246 (H Street and Ocean Avenue) that represents the needs of the community; and

**WHEREAS**, the City, on May 17, 2019, was awarded a Caltrans Grant of \$258,500 to begin grant work for the Project on November 1, 2019; and

**WHEREAS**, on July 2, 2019, the City Council adopted Resolution No. 6288(19) authorizing a Restricted Grant Agreement between the City and Caltrans before funds can be claimed through the Transportation Planning Grant Programs for the Project; and

**WHEREAS**, the funding sources for the Project consist of the following:

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
