## **REPORT ON ACTION TAKEN DURING CLOSED SESSION:**

City Attorney Jeff Malawy reported Council Member Mosby was absent from the Closed Session due to a real property conflict of interest, and the Council took no reportable action during the Closed Session.

Mayor Jenelle Osborne led the Pledge of Allegiance.

City Manager Jim Throop removed this item from the Agenda, stating the County has been moved to a lower level tier and with social distancing and mask wearing protocols observed, all City Bodies can hold meetings open to the public.

• Discussion of Possible Continuation of Cancelling Commission, Committee, and Board Meetings, With the Exception of the Planning Commission, due to COVID-19.

Mr. Throop announced the Parks Division is working to re-open all playgrounds with updated COVID-19 requirements signs; new recreation park equipment is being installed at Beattie Park with an estimated completion of Mid-November 2020; the Library received a private donation which will allow for the carpet in the Lompoc Library to be replaced; a public meeting for the rehabilitation of College Park with a Prop 68 Grant will be upcoming soon; and the Census deadline has been extended to October 31, 2020.

## **PUBLIC COMMENT ON CONSENT CALENDAR ITEMS** (Maximum of 3 Minutes):

1. Steve Franck spoke about Consent Calendar Item No. 3 and requested Council approve the extension.

#### **CONSENT CALENDAR:**

Council Member Mosby requested the second response letter attached to Consent Calendar Item No. 5 be revised to include "dedicated grant writer" on page 2 of 3 response to Recommendation 6b; and asked Staff to confirm what monies are to be used to fund the recruitment and retention incentives on Consent Calendar Item No. 6. Human Resources Manager Gabriel Garcia stated the monies are from long term salary savings.

- 2. Regional Early Action Planning (REAP) Grant; Adoption of Resolution No. 6363(20).

Adopted Resolution No. 6363(20) as part of the Regional Early Action Planning (REAP) Grant application requirements and authorized the City Manager to execute any required documents associated with such funding application and/or award.

3. Approval of a Second Amendment to the Memorandum of Understanding with Pale Blue Dot Ventures, Inc, for Potential Sale of Approximately 82 acres of City-owned Property, Including and Adjacent to Ken Adam Park, for Development of a Space Center.

Approved the proposed Second Amendment to the Memorandum of Understanding (MOU) with Pale Blue Dot Ventures Inc. (PBDV) (Second Amendment), which would extend the timelines established by the MOU due to the COVID-19 crisis.

4. Approval of Agreement for Operation of a County-Wide Library System.

Approved, and authorized the City Manager to execute, the Agreement for Operation of a County-Wide Library System between the County of Santa Barbara, and the cities of Santa Barbara, Lompoc, Santa Maria, and Goleta for the Fiscal Year (FY) 2020-21.

Reviewed the Santa Barbara County Grand Jury reports entitled <u>Detention Facilities in Santa Barbara County</u> and <u>Juveniles in Gangs in Santa Barbara County</u> and approved the proposed response letters presented on behalf of the City, pursuant to California Penal Code Sections 933(c) and 933.05(a), (b) and (c), with the following revision to the response letter to the report Juveniles in Gangs in Santa Barbara, "dedicated grant writer" be added to the response to Recommendation 6b on page 2 of 3.

6. Adoption of Resolution No. 6364(20) Related to the Retention and Recruitment Incentive for Classifications within the Electric Division.

Adopted Resolution No. 6364(20) and approved the Retention and Recruitment Incentive for specified classifications within the City's Electric Division.
