Public Hearing Item No. 1:

Discussion of the Draft 2020 Development Impact Fees Study

<u>LOM 627 – Lot Line Adjustment for two Industrial lots located at 224 North A Street</u> and 812 East Chestnut Avenue

A request from Ted Crocker (applicant) for Planning Commission consideration of a Lot Line Adjustment to remove an interior lot line between two lots that are 1.45 acres and 1.73 acres in size to create one 3.18 acre lot located at 224 North A Street and 812 East Chestnut Avenue (APN's: 085-110-001 and 085-110-011) in the Industrial (I) zone. This action is not subject to the California Environmental Quality Act (CEQA) because it does not involve the exercise of discretionary powers by a public agency.
