

**RESOLUTION NO. 6392(21)**

**A Resolution of the City Council of the City of Lompoc,  
County of Santa Barbara, State of California,  
Adopting the Supplemental Appropriations  
for City of Lompoc Transit–  
Capital Outlay for Purchase of Transit Buses**

**WHEREAS**, on June 26, 2019, City Council of the City of Lompoc (City) approved and adopted the Biennial Budget Fiscal Years (FY) 2019-21; and

**WHEREAS**, the funding sources for the transit buses consist of the following:

Transportation Development Act (TDA)	\$ 278,858.11
State of Good Repair Grant	<u>\$480,196.31</u>
Total estimated resources (revenues)	\$ 759,054.42

**WHEREAS**, the City Council desires to appropriate funds to provide for transit bus purchases; and

**WHEREAS**, these transit bus purchases from A to Z Bus Sales will be under the current contract prices, terms and conditions of the California Association of Coordinated Transportation (CalAct) competitively-awarded contract. CalAct is a cooperative purchasing association of California transit agencies who have joined together with a goal of combining their purchasing power. The Lompoc Municipal Code (LMC) provides for cooperative purchases such as through CalAct.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:**

**SECTION 1.** The City Manager is authorized to expend \$759,054.42 in funds for the purchase of five transit buses from A to Z Bus Sales.

**SECTION 2.** The existing sources and the uses of resources are approved as follows:
