A Resolution of the Council of the City of Lompoc, County of Santa Barbara, State of California, Approving the Fiscal Year 2021-22 Budgets for CDBG and Human Services Funds and Necessary Certifications and Authorizations Required by HUD

WHEREAS, the Housing and Community Development Act of 1974, as amended, provides for assistance to local governments to develop programs which create viable urban communities; and

WHEREAS, the City of Lompoc (City) received notification from the U.S. Department of Housing and Urban Development (HUD) of the Fiscal Year (FY) 2020-21 allocations for Office of Community Planning and Development's (CPD) formula programs, which provide funding for housing, community and economic development activities, and assistance for low- and moderate-income persons and special populations across the country; and

WHEREAS, the City's FY 2021-22 Community Development Block Grant (CDBG) available amount is \$530,174; and

WHEREAS, a 30-day public review and comment period (April 5, 2021 – May 5, 2021) was noticed to the public on the City of Lompoc website on April 5, 2021, for \$530,174 in CDBG Funding, and

WHEREAS, a public hearing was held on May 4, 2021, to obtain public comments and proposals for inclusion in the FY 2021-22 Lompoc Annual Action Plan; and

WHEREAS, at its meeting of May 4, 2021, the City Council took public testimony on the Draft FY 2021-22 Lompoc Annual Action Plan.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The Lompoc FY 2021-22 CDBG Budget (Summary Budget is attached hereto as Exhibit "A") is hereby adopted.

SECTION 2. The Lompoc FY 2021-22 supplemental appropriations (Line Item Budget attached hereto as Exhibit "B") is hereby adopted.

SECTION 3. To comply with requirements of the FY 2020-21 Annual Action Plan and to properly administer the CDBG and Human Service funds on behalf of the City, the City Manager, or designee, is hereby authorized to execute all necessary agreements, documents, and certifications (including, but not limited to, loan documents, demand statements, default notices, foreclosure actions, reconveyances, subordinations, loan workouts, assumptions, promissory notes, deeds of trust, escrow documents, Request for Release of Funds Form #HUD-7015.15, federal environmental review documents, and Section 108 loan documents).
