A Resolution of the City Council of the City of Lompoc,
County of Santa Barbara, State of California,
Approving Supplemental Appropriations and Supplemental
Revenues for the Acquisition of a Solid Waste Landfill Compactor Vehicle

WHEREAS, the City Council of the City of Lompoc (City) adopted Resolution No. 6299(20) on January 21, 2020, approving lease financing for the appropriation of a landfill compactor; and

WHEREAS, the acquisition of a Caterpillar Landfill Compactor (Compactor) model 826 K replaces the existing 1995 Compactor model 826 C which has exceeded its 20-year operational life and is in need of replacement; and

WHEREAS, the bid received from Quinn Company was the highest qualifying bid meeting the requirements of Request for Proposal No. 2964; and

WHEREAS, the City Council desires to complete the purchase of the replacement Compactor from Quinn Company and to appropriate funds for the completion of the purchase.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The award of a purchase order contract for the Compactor is made to the Quinn Company based on the criteria outlined in the Request for Proposal No 2964.

SECTION 2. Budget appropriations are for the purchase of the replacement Compactor approved at the July 6, 2021, City Council meeting and related revenue or reserves are approved as follows:
