1. Parks and Recreation Division monthly update - Mario Guerrero Jr., Parks and Recreation Manager

Mario Guerrero, Jr., provided updates in the Parks and Recreation Division:

- 8 or 9 RV Campsites are being updated and will be completed in about a month and will continue on to the next 13 spaces.
- Beattie Park Phase 2 will be going out to bid within the next month and will include a lighted walkway, ADA access, two new parking spaces and another BBQ area that can be reserved.
- 4<sup>th</sup> of July had a great show and was one of the most attended shows
- Olive trees were replaced at City Hall and soon to be Centennial Park as there were irrigation problems caused by the existing trees
- Little League Regional Tournament will be held this weekend
- Local Carpenters Union 805 volunteered and made improvements to areas at Ryon Park to include painting the concession stand, installed a new roof and updated the announcers booth

- New seed, soil and sod on the football field and is fenced in to keep the public off the field
- The Parks and Recreation front office is fully open with all normal Fall programs returning besides the Splash Pass.
- City Non-Profit will be established with 1 Council member, 2 Business members from the community (not in the same business), 4 Chair Members and the City Manager will be the Executive Member
- Cannabis Tax will be on the September 14, 2021 Ballot
- Lompoc High School Track trial run ends July 31, 2021 and Lompoc Unified School District will be taking over

- 2. Commissioner Baker mentioned that he attended the 4<sup>th</sup> of July show and was a great turn out and thanked Johanna Kinard and Chad Dawson. He also asked if Commission can get an updated Special Events Calendar now that events are returning. Lastly he stated Lompoc Girls Softball Association held an All Star Tournament and utilized Thompson and Providence Landing Fields and had 21 teams registered.
- 3. Commissioner Braxton asked if the Christmas Parade is still being held the first Friday of December. Mario replied yes.
