1. Parks and Recreation Division monthly update - Mario Guerrero Jr., Parks and Recreation Manager

Mario Guerrero, Jr., provided updates in the Parks and Recreation Division:

- Indoor mask mandate returned
- Last week of Summer Drop In
- Cannabis in the Parks item was tabled by Council until possibly the beginning of 2022 to obtain more research from other Cities
- Pool closure August 14-30<sup>th</sup>; replacing Therapy Pool pump, maintenance around the facility and the play structure
- All regular programming will begin in the fall Youth Basketball, Photo Contest, etc
- Brochure will be strictly online with PDF copies to Active members
- Poured nine concrete slabs at the River Park Campgrounds and should be fully operational in September
- Beattie Park was closed on August 9<sup>th</sup> for maintenance on the playground such and was power washed. Memo will go out for no food, drinks or chalk allowed at that park.
- Phase 2 at Beattie Park installing bbq/gazebo, upgrading to ADA access, updating lighting and on August 17<sup>th</sup> an ordenance for feeding wild animals to include squirrels.
- Lompoc Youth Football Jamboree will be held at Lompoc High School Stadium instead of Ryon Park this year
- Working on setting up a Riverbend work day with Lompoc American Youth Soccer Organization
- September 16 will be the Landsat 9 Launch and will have exhibits at the Lompoc Library, Geocatching and the kick off will be September 12<sup>th</sup> at the Dick DeWees Community and Senior Center
