3. Adoption of Resolution No. 6450(21) Approving Amendment No. 3 to the Memorandum of Understanding With Employees Represented by the International Brotherhood of Electrical Workers, Local Union 1245 and Approving Supplemental Appropriations to Fund the Amended Compensation Plan.

Council Member Starbuck asked Staff to confirm the proposed adjustments include the career ladder steps in the request for appropriations. Human Resources Manager Gabriel Garcia assured Council the projections in the Staff report do include career ladder steps.

ACTION: Motion/Second: Starbuck/Vega By a 4-0-1 vote, (Council Member Cordova was absent) Council adopted Resolution No. 6450(21), which will approve Amendment No. 3 to the Memorandum of Understanding (MOU) between the International Brotherhood of Electrical Workers, Local Union 1245 (IBEW 1245) and the City (Amendment), providing equity adjustments to certain positions in the Management Services Department, Treasury and Finance Divisions; approved the proposed equity adjustments as prescribed in the Amendment; amended the City's Compensation Plan to include the equity adjustments as prescribed in the Amendment; approved the supplemental appropriations which will fund the proposed equity adjustments for Fiscal Year 2021-23; and approved the supplemental resources to fund the supplemental appropriations.
