Council Members Present: Victor Vega, Dirk Starbuck, Gilda Cordova, Jeremy Ball, and Mayor Jenelle Osborne. Council Member Ball arrived at 6:33 P.M.

Staff Present: City Manager Dean Albro, City Clerk Stacey Haddon, and City Attorney Jeff Malawy.

PUBLIC HEARING:

1. **Public Hearing to Receive Community Input on the Composition of Districts for City Council Offices and the Redrawing of Election District Boundaries; and Introduce Ordinance No. 1690(22), Amending Section 2.06.030 of the Lompoc Municipal Code to Adopt a City Council Electoral Districts Map based on the 2020 Census.**

Stacey Haddon, City Clerk presented the Staff report and introduced Daniel Phillips, Phd. of National Demographics Corporation who presented a brief review of the redistricting process, the requirements for a balanced election district boundary map, and the four draft maps.

Public Comment: None

Council thanked Dr. Phillips for the presentation and provided information.

Council Member Ball expressed concern about equal population in all districts as currently District 4 is shown to be the least populated.

Council Member Vega stated he is in favor of moving forward with draft map 1 – no change or with draft map 2 – minimal change.

Mayor Osborne agreed with Council Member Vega and is in favor of draft map 1 – no change or draft map 2 – minimal change, and prefers draft map 2 – minimal change.

Council Member Ball requested draft map 3 – moderate change be considered, as this could help District 4 be more equalized in population count with all other districts.

Council Member Cordova stated she is in favor of draft map 1 – no change or draft map 2 – minimal change, and prefers draft map 2 – minimal change.

Council Member Starbuck asked for clarification of the voter shift with draft map 2 – minimal change. Dr. Phillips stated the change is .2%

ACTION: Motion/Second: Vega/Starbuck. By a 5-0 vote, Council received a presentation from National Demographic Corporation; held the Public Hearing to receive public input on proposed election district boundary draft maps; and introduced by title only with further reading waived, Ordinance No. 1690(22), amending Section 2.06.030 of the Municipal Code to adopt a City Council Electoral Districts Map based on the 2020 Census.

ADJOURNMENT: At 7:04 P.M. Mayor Osborne adjourned the Lompoc City Council to a Regular Meeting on March 1, 2022 at 6:30 P.M., in City of Lompoc Council Chamber.
