Ordinance No. 1690(22)

An Ordinance of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Amending Section 2.06.030 of the Lompoc Municipal Code to Adopt A City Council Electoral Districts Map Based on Results of the 2020 Census

WHEREAS, the members of the City Council of the City of Lompoc (City) are currently elected by-district with four single-member districts and one at-large elective mayor, pursuant to California Government Code sections 34886 and 34871, and as described in Chapter 2.06 of the Lompoc Municipal Code; and

WHEREAS, Elections Code section 21601 and Lompoc Municipal Code section 2.06.030(B) require that following each federal decennial census, the City Council shall adopt boundaries for all of the council districts of the city so that the council districts shall be substantially equal in population as required by the United States Constitution, and in compliance with all other laws, based on that latest federal census; and

WHEREAS, a federal decennial census was conducted in 2020 and the results released in 2021; and

WHEREAS, pursuant to Elections Code section 21602, the City Council must adopt such boundaries not later than April 17, 2022; and

WHEREAS, the City Council has held four public hearings at which members of the public were invited to provide input regarding the composition of the City Council districts (on July 6, 2021, July 20, 2021, February 2, 2022, and February 16, 2022).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Findings. The City Council finds as follows:

- A. The above recitals are true and correct and are incorporated herein by this reference.
- B. The City Council hereby declares the intent and purpose of this Ordinance adopting a districts map for the City's district-based system of elections for members of the City Council is to further the purposes of the California Voting Rights Act of 2001 (Chapter 1.5 (commencing with Section 14025) of Division 14 of the Elections Code).

SECTION 2. Section 2.06.030 of the Lompoc Municipal Code is hereby repealed and replaced, in its entirety, as follows:

2.06.030 Establishment of City Council Electoral Districts.

- A. Subject to the provisions of this chapter, members of the City Council shall be elected by-district from City Council districts shown and numbered on the map titled 'City of Lompoc District Map', a copy of which shall be on file in the City Clerk's office, and which is attached as Exhibit A to this ordinance.
- B. The City Council electoral districts described in this section shall be adjusted from time to time, as required by California Elections Code sections 21600, et seq., or by other law.

SECTION 3. Effective Date. This Ordinance shall be effective on the thirty-first day after its adoption.


