CONSENT CALENDAR:

ACTION: Motion/Second: Ball/Vega. By a 5-0 vote, Council:

- 1. Approved the Minutes of the Lompoc City Council Regular Meeting of February 1, 2022 and of the City of Lompoc City Council Special Meeting of February 16, 2022.
- 2. Adoption of Resolution No. 6479(22) Authorizing Acceptance of American Public Power Association's Award of Demonstration of Energy and Efficiency Developments Scholarship Program Funds to be Used Toward a Paid Student Internship in the Utility Conservation Division.

Adopted Resolution No. 6479(22), which will grant the City Manager, or his designee, authority to execute Contract CS-2569 and accept the Demonstration of Energy and Efficiency Developments Scholarship Program award offer from the American Public Power Association; and grant the City Manager, or his designee, authority to execute any and all necessary documents related to the scholarship award offer listed in Contract CS-2569 through the Demonstration of Energy and Efficiency Developments Scholarship Program administered by the American Public Power Association, to permit the award to be used towards a paid student internship within the City's Utility Conservation Division.

3. Adoption of Ordinance No. 1688(22), Changing the Method For Filling Vacancies on Some City Commissions to Allow Commissioners to Be Appointed from Outside the Appointing Councilmember's District, in Some Circumstances

Adopted Ordinance No. 1688(22) changing the method for filling vacancies on the Beautification & Appearance Commission, Parks & Recreation Commission, Planning Commission, and Utility Commission to allow commissioners to be appointed from outside of the appointing Council Member's district, in some circumstances. (Note: These changes for Human Services and Public Safety Commissions were adopted by resolution on February 1, 2022.)

6. Council Appointment to Beautification & Appearance Commission.

<u>ACTION</u>: Motion/Second: <u>Vega/Cordova</u>. By a 4-1 vote (Mayor Osborne voted No), Council appointed Lee Weir to the Beautification Commission for a temporary appointment for District 2, which will begin as of April 1, 2022.

COUNCIL REQUESTS:

7. Adoption of Resolution No. 6480(22) Authorizing Participation in a Memorandum of Understanding with Santa Barbara County Association of Governments, County of Santa Barbara, and the cities of Santa Barbara, Santa Maria, Goleta, Carpinteria, Guadalupe, Solvang, and Buellton to Prepare a Regional Broadband Strategic Plan (Mayor Osborne)

Rich Gracyk, Broadband Administrator presented the Staff report and recommendations and introduced Marjie Kirn the Executive Director of the Santa Barbara County Association of Governments. Ms. Kirn gave a brief presentation on the Regional Broadband Strategic Plan.

Council discussed the matter at length, including the City's current Wi-Fi system, the cost to the City for participating in this plan, the need for a long rang plan for broadband services to attract businesses to locate to the area and to provide internet access to citizens.

Public Comment:

1. Deb Andrews asked if Starlink could be a viable option for internet access for the City.

<u>ACTION</u>: Motion/Second: <u>Ball/Vega</u>. By a 4-1 vote (Council Member Starbuck voted No), Council adopted Resolution No. 6480(22) approving, and directing the Mayor to sign, a Memorandum of Understanding (MOU) with the Santa Barbara County Association of Governments (SBCAG), County of Santa Barbara (County), and the cities of Santa Barbara, Santa Maria, Goleta, Carpinteria, Guadalupe, Solvang, and Buellton to prepare a regional broadband strategic plan, which includes a financial contribution from the City of \$27,608.90.

NEW BUSINESS:

8. Introduction of Ordinance No. 1691(22) Implementing Senate Bill 1383 Requirements Relating to Organic Waste Disposal Reduction

Keith Quinlan, Solid Waste Superintendent presented the Staff report and recommendations.

City Attorney Jeff Malawy stated there are a few typographical errors in the proposed ordinance and asked Council to approve the revisions if this item is approved this evening.

NEW BUSINESS: (cont'd)

Item No. 8

Council discussed the presented information at length, including the need for education to citizens and business owners of these new and upcoming regulations, possible future solid waste rate increases, and the fact this is a California State mandate and provides no exceptions to any city, county, district, or agency.

Public Comment:

1. (Name not provided) expressed concern about increases in cost of services to rate payers and possible increased smells and pest activity with these new regulations.

<u>ACTION</u>: Motion/Second: <u>Mayor Osborne/Ball</u>. By a 5-0 vote, Council introduced, for first reading by title only with further reading waived, Ordinance No. 1691(22), adding Article 6 to Chapter 8.04 of Title 8 of the Lompoc Municipal Code (LMC) which mandates organic waste disposal reduction; with the Ordinance being revised as recommended by the City Attorney and shown below:

8.04.420 Requirements for Commercial Businesses

(1) Generator shall place Source Separated Food Waste Scraps in the Green Container, Source Separated Green Container Organic Waste, excluding Food Waste, in the Green Container; Source Separated Recyclable Materials in the Blue Container; and Gray Container Waste in the Gray Container. Generator shall not place materials designated for the Gray Container into the Green Container or Blue Container.

8.04.490 Compliance with CALGreen Recycling Requirements

(a) Persons applying for a permit from the City for new construction and building additions and alternations shall comply with the requirements of this Section and all required components of the California Green Building Standards Code, 24 CCR, Part 11, known as CALGreen, as amended, if its project is covered by the scope of CALGreen or more stringent requirements of the City. If the requirements of CALGreen are more stringent then than the requirements of this Section, the CALGreen requirements shall apply.

Mayor Osborne reported she attended several meetings and events including the badge pinning ceremony for Lompoc Fire Department Battalion Chief Carol Brown, the annual Count in Time event, meetings for the Northern California Power Agency (NCPA) and the Santa Barbara County Association of Governments (SBCAG); and toured the Homekey project on B Street; and announced the City will host an Arbor Day Celebration and tree planting event at River Park on March 12, 2022 from 8am – Noon; the annual Surf Beach restricted area closures are to be from March 1, 2022 through September 30, 2022; the City's Youth Commission Teaching Our Teens As Leaders (TOTAL) Teen Conference will be held at the DeWees Community and Senior Center on March 25, 2022 from 9am – 2pm; and daylight savings begins on March 13, 2022.
