4. Adoption of Ordinance No. 1691(22) Implementing Senate Bill 1383 Requirements Relating to Organic Waste Disposal Reduction

Adopted Ordinance No. 1691(22), adding Article 6 to Chapter 8.04 of Title 8 of the Lompoc Municipal Code (LMC) which mandates organic waste disposal reduction.

5. Adoption of Urgency Ordinance No. 1692(22), Authorizing Temporary Outdoor Dining Through December 31, 2022 at Restaurants and Food Service Establishments to Alleviate Economic Hardship and Preserve Public Peace, Health and Safety.

Christie Alarcon, Community Development Director presented the Staff report and recommendations.

Council discussed the information presented at length.

Public Comment:

1. Deb Andrews thanked Council and Staff for holding this discussion.

Council thanked Staff or this report and for the work that will need to be completed to educate and provide guidance to any and all businesses which currently have outdoor dining and may wish to continue to offer outdoor dining; and encouraged any and all businesses wanting outdoor dining to contact the City's Planning and Building Divisions so Staff can help provide the needed information.

<u>ACTION</u>: Motion/Second: <u>Vega/Cordova</u>. By a 5-0 vote, Council adopted, by a unanimous vote of the entire Council, Urgency Ordinance No. 1692(22), authorizing temporary outdoor dining at restaurants and food service establishments through December 31, 2022, to alleviate economic hardship and preserve public peace, health and safety.

2. Acceptance of the 2021 General Plan Annual Report.

Council discussed this matter which included asking Staff if the Council Ad-Hoc Committee recommendations for revisions to the General Plan will be brought forward for a Council discussion; can a City vision statement be included in the General Plan update; if the Regional Housing Needs Allocation (RHNA) requirement for Lompoc has been increased; and how does the City currently handle code violation complaints Planning Manager Brian Halvorson stated the Council Ad-Hoc Committee suggestions will be brought forward by the consultant when the General Plan update is brought to Council; and the RHNA requirement has increased by the State for the City from 527 to over 2200 and those numbers must be planned for in the City's zoning and General Plan. Community Development Director Christie Alarcon explained the code enforcement process is quite challenging without a code enforcement officer, but Staff does work hard to address all complaints.

Mayor Osborne asked for Staff to clearly classify recommended General Plan amendments provided by the consultant and provided by the Council Ad-Hoc Committee.
