## Resolution No. 6497(22)

A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Adopting the Supplemental Appropriations for Fleet Fuel Account for Remainder of Fiscal Year 2021-22 and Fiscal Year 2022-23

**WHEREAS,** on June 15, 2021, City Council of the City of Lompoc (City) approved and adopted the Biennial Budget Fiscal Years (FY) 2021-23; and

**WHEREAS**, fuel costs have increased approximately 70% since January 2022; and

**WHEREAS** increased costs for fuel for the remainder of Fiscal Year (FY) 2021-22 are estimated at \$396,558; and

**WHEREAS** increased costs for fuel for FY 2022-23 are estimated at \$753,000; and

**WHEREAS** increased costs for fuel were not included in the adopted Biennial Budget FYs 2021-23; and

**WHEREAS**, the funding sources for the Fleet fuel costs are allocated to each fund as detailed in Attachment A attached hereto; and

**WHEREAS**, in response to these externalities, the City Council desires to provide supplemental appropriations for FY 2021-22 in the amount of \$396,558 and for FY 2022-23 in the amount of \$753,000 to meet the needs of the Fleet Division.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
