A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Adopting Addendum to the Mitigated Negative Declaration ER20-19, Adopting the Plans and Special Provisions, Awarding the Contracts for Construction and Construction Management, and Approving Supplemental Appropriations for Project No. FY-21-WW-1, VVCSD Interceptor Sewer Siphon Relocation at Floradale Avenue

WHEREAS, the City of Lompoc (City) receives influent sewage into its sewer pipes and treatment plant from the Vandenberg Village Community Services District (VVCSD) pursuant to the Wastewater Service Agreement (Service Agreement) between the City and VVCSD, effective July 1, 2010; and

WHEREAS, the County of Santa Barbara is currently constructing a new bridge to replace the existing Floradale Avenue bridge which supports the VVCSD interceptor sewer line across the Santa Ynez River, and the sewer line must be relocated prior to December 2022 when demolition of the existing bridge may begin; and

WHEREAS, the City and VVCSD entered into a Reimbursement Agreement for the Floradale Sewer Relocation Project (Project) on May 5, 2020, through which VVCSD agreed to reimburse the City for all Project costs; and

WHEREAS, the City Council of the City adopted the Mitigated Negative Declaration (MND) (ER20-19) (SCH NO. 2021020258) by Resolution No. 6394(21) at the April 6, 2021, City Council meeting, and directed staff to implement the Project and return to the City Council for approval of the construction contract and any other necessary items; and

WHEREAS, staff and its consulting team completed the Project design, received construction bids, and prepared a necessary addendum to the MND (Addendum) due to minor revisions to the Project; and

WHEREAS, the Addendum was prepared in compliance with the California Environmental Quality Act (CEQA) and its guidelines, including Sections 15162 and 15164 of the CEQA guidelines, and with the Environmental Guidelines of the City; and

WHEREAS, the Addendum reflects the City's independent judgment and analysis; and

WHEREAS, the City Council has reviewed and considered the MND and the Addendum, and finds that there is no substantial evidence in the record the Project will

have a significant effect on the environment, with implementation of the identified mitigation measures; and

WHEREAS, the City Council desires to complete the Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. After review and consideration of the Project, the Addendum, and the MND; considering the evidence and upon due deliberation of the matters presented, the City Council adopts the Addendum to Mitigated Negative Declaration, ER20-19 (Attachment 2 to the May 17, 2022, City Council staff report).

SECTION 2. The Plans and Special Provisions for the Project are hereby adopted, as required by Section 22039 of the Public Contract Code; copies of Plans and Special Provisions are on file in the City Engineer's office.

SECTION 3. The construction contract for the Project in the amount of \$1,476,210 is hereby awarded to Tierra Contracting, Inc.;

- a. The City Manager is authorized to execute the necessary agreements for that Contract:
- b. The City Engineer, or designee, is authorized to approve additional construction costs and construction contract change orders in an amount not to exceed \$200,000.

SECTION 4. The consulting contract for Construction Management, Inspection, and Construction Materials Testing Services (Construction Management Contract) for the Project is hereby awarded in the amount of \$151,610 to Filippin Engineering, Inc.;

- a. The City Manager is authorized to execute the necessary agreements for the Consulting Contract;
- b. The City Engineer, or designee, is authorized to approve additional costs and consulting contract change orders in an amount not to exceed \$25,000.

SECTION 5. Supplemental budget appropriations for the Project are approved as follows:
