THIRD AMENDMENT TO CONTRACT SERVICES AGREEMENT FOR CITY ATTORNEY LEGAL SERVICES CITY OF LOMPOC

This Third Amendment is made and entered into by and between the CITY OF LOMPOC, a municipal corporation, hereinafter referred to as "City," and ALESHIRE & WYNDER, LLP, a California limited liability partnership, hereinafter referred to as "Firm."

WHEREAS, as of December 1, 2009, the parties entered into a contract for the provision of city attorney legal services, which was amended effective July 1, 2015 to adjust hourly rates, and again amended effective December 6, 2018 to appoint Jeff Malawy as City Attorney (collectively, the "Amended Agreement"); and

WHEREAS, the City Council authorized the City Manager to sign this further amendment to the Amended Agreement.

NOW THEREFORE, in consideration of the foregoing, City and Firm mutually agree as follows:

1. Effective July 1, 2022, Section 5. of the Amended Agreement is amended to modify the compensation as follows:

Document Clerks	\$ 75.00/hour
Lodging Reimbursement	Cap of \$200/week of meeting

2. Effective July 1, 2023, Section 5. of the Amended Agreement is amended to modify the compensation as follows:

First 50 hours of general services	\$210.00/hour
Hours over 50 for general services	\$225.00/hour
Special services	\$250.00/hour
Insurance defense	\$230.00/hour
Private party reimbursement	\$395.00/hour
Non-contingent public financing	\$400.00/hour
Paralegals/Law Clerks	\$145.00/hour

- 4. Except as expressly set forth herein, all terms and conditions of the Amended Agreement shall remain in full force and effect.
- 5. This Amendment shall be effective on the date it is signed on behalf of City, as long as it has also been signed on behalf of the Firm.
