## **RESOLUTION NO. 6530(22)**

A Resolution of the City Council of the City of Lompoc,
County of Santa Barbara, State of California,
Approving Amendment No. 1 to the Memorandum of Understanding
with the Employees Represented by the
Lompoc Police Officers' Association

**WHEREAS**, on June 7, 2022, the City Council adopted Resolution No. 6509(22) approving the Lompoc Police Officers' Association Memorandum of Understanding 2022-23 (LPOA MOU 2022-23); and

WHEREAS, the City and LPOA authorized labor relations representatives have met and conferred regarding the proposed benefits adjustments, and on June 28, 2022, the parties have jointly prepared and ratified Amendment No. 1 to the LPOA MOU 2022-23 (Amendment No. 1) attached hereto as Exhibit A; and

**WHEREAS**, the City Council now desires to accept, approve, and adopt Amendment No. 1 to reflect the proposed benefits adjustments, as detailed in Exhibit A attached hereto; and

**WHEREAS,** the City Council also desires to, and provides funding for, the impacts of the proposed changes delineated below.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

**SECTION 1.** Amendment No. 1, which provides for the benefits adjustments delineated below (attached hereto as Exhibit A) is hereby accepted, approved, and adopted.

- **Bilingual Pay:** Increase bilingual pay from \$100 to \$150 per month effective after City Council adoption of resolution on July 5, 2022.
- **Group Basic Life**: Effective July 1, 2022, and upon approval by Voya Insurance, whichever is later, the City shall increase the group basic life insurance coverage to LPOA represented employees equivalent to two times their annual salary up to a maximum coverage of \$300,000.
- Sick Leave Incentive: Effective after City Council adoption of resolution on July 5, 2022, LPOA represented employees who have five (5) years consecutive sick leave eligibility shall be entitled to a \$200 increased sick leave incentive for a total of sick leave incentive of \$500 annually to be calculated after the first pay period ending in December and paid on the second pay period ending in December.

**SECTION 2.** The City Council approves supplemental appropriations to fund the Fiscal Years (FY) 2022-23 due to the bilingual pay, sick leave incentive, and group basic life adjustments as follows:
