

RESOLUTION NO. 968(22)

**A Resolution of the Planning Commission of the City of Lompoc,
County of Santa Barbara, State of California,
Approving the Lompoc Streetscape Multimodal
Improvement Plan (GR 18-01) For Conceptual
Transportation Improvements Relating To Traffic Safety,
Bicycle and Pedestrian Improvements, Multi-Modal
Connections, Corridor and Landscaping Enhancements
Along H Street and Ocean Avenue
(State Highways 1 And 246)**

WHEREAS, on May 17, 2019, the City of Lompoc (City) was awarded a Sustainable Communities Transportation Grant from the California Department of Transportation (Caltrans) to create the Lompoc Streetscape Multimodal Improvement Plan (LSMIP); and

WHEREAS, the LSMIP addresses the Lompoc community's needs for traffic safety, multimodal connections, bicycle/pedestrian improvements, and streetscape beautification along Ocean Avenue and H Street; and

WHEREAS, community outreach and engagement with stakeholders, community members, and decision members were conducted virtually and in person and community input was incorporated into the LSMIP; and

WHEREAS, the LSMIP (GR 18-01) was considered at a joint meeting of the Planning Commission and City Council on July 19, 2022.

NOW, THEREFORE, THE PLANNING COMMISSION OF THE CITY OF LOMPOC, CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Findings. The Planning Commission makes the following findings:

- A. Preparation of the LSMIP and City's consideration of the recommendations in the LSMIP are consistent with the Goals, Policies, and Measures of the 2030 General Plan.
- B. Preparation of the LSMIP and City's consideration of the recommendations in the LSMIP are consistent with the intent and purpose of Title 17 (Zoning) of the Lompoc Municipal Code.
- C. Preparation of the LSMIP and City's consideration of the recommendations in the LSMIP will serve the public necessity, convenience, and general welfare.

- D. Approval of the LSMIP as a list of projects for future consideration (not including approval or commitment to construct or implement any project recommended by the Plan) is exempt from environmental review pursuant to Section 15262 (Feasibility and Planning Studies) of the California Environmental Quality Act (CEQA) Guidelines. The adoption of the LSMIP by this resolution has no legally binding effect on later activities, and is not a commitment to implement, construct, fund, or require construction of any project. Approval or implementation of any project recommended by the LSMIP will require separate environmental review and separate future consideration and approval by the City Council, unless such project is exempt from CEQA.

SECTION 2. The LSMIP (attached as Attachment 3 to the July 19, 2022 staff report) is hereby adopted.

SECTION 3. Effective Date. This Resolution is effective on the day of its adoption.
