A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Approving Supplemental Appropriations for Project No. FY-22-S-2, 2022 Street Pavement Digout Project

WHEREAS, the City Council of the City of Lompoc (City) approved street paving projects as part of the Biennial Budget Fiscal Years 2021-23 on June 3, 2021, and

WHEREAS, the City has implemented an ongoing capital project street rehabilitation program (Program) in order to replace failed street pavement and resurface City streets to promote safety and mobility for the greatest number of users as efficiently as possible, limited in scope to available road funding resources; and

WHEREAS, as part of the Program, the City has developed Project No. FY-22-S-2, 2022 Street Pavement Digout Project (Project), to remove and replace existing failed pavement in various City streets and alleys, and also at the Solid Waste Yard at 1585 V Street; and

WHEREAS, such street pavement repairs cost-efficiently replace limited failed pavement areas while saving the surrounding sound pavement for continued use, and will complement and enhance the performance of a separate pavement cape seal project planned for completion later this year along the same City street segments and three alleys; and

WHEREAS, the City Council desires to complete Project by appropriating City Street and Alley Rehabilitation Program funds, Special Gas Tax (Senate Bill 1) Funds, Measure A Funds, and Solid Waste funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
