

# Adopted Minutes of the Adjourned Special Meeting of the Lompoc Planning Commission Wednesday, June 8, 2022, at 6:30 P.M. City Hall, 100 Civic Center Plaza, Council Chambers

### **PUBLIC HEARING ITEMS:**

**Public Hearing Item No. 1:** 

Consideration of Zoning Code Amendments (TA 22-01) Revising the Method for Calculating the In-Lieu Fee in the Inclusionary Housing Ordinance (Continued from the April 13, 2022 Meeting)

Planning Commission consideration of amendments to Chapter 17.324 (Inclusionary Housing) and Chapter 17.704 (Definitions) to revise the basis for calculating the fee that may be paid by developers in lieu of constructing on-site affordable units in housing development projects. This action is exempt from environmental review pursuant to Section 15061(b)(3) (the "common sense" exemption) of the California Environmental Quality Act (CEQA) Guidelines.

**Brian Halvorson, Planning Manager,** presented the staff report in a PowerPoint presentation.

# **Open Public Comment for TA 22-01**

**Jon Martin**, Burton Ranch Developer, (due to technical difficulties **Mr. Martin's** comments were not captured on the audio recording), agreed with City Staff's recommendation to decrease the in-lieu fee and stated that there should be no fee for rentals. **Mr. Martin** then summarized the May 20, 2022 comment letter presented as attachment Number 4 to the staff report.

**Steve Bridge**, a resident, stated that HAP is a good program that does provide funding opportunities for the community but does not create new housing, it creates a higher demand.

# **Close Public Comment for TA 22-01**

**Commissioner Gonzales** inquired if Santa Maria is building affordable housing.

**Mr. Halvorson** stated that the City of Santa Maria does have and continues to build affordable housing, but the City of Santa Maria does not have an ordinance requiring them to build a certain percentage of affordable housing in their new developments.

Christie Alarcon, Community Development Director, stated that Santa Maria has larger allocations of home funding for affordable housing developments and is supportive of affordable housing production (which depend on market rate production) and mentioned that they utilize subsidies that are intended for affordable housing as opposed to inclusionary housing policies.

**Commissioner Cioni** inquired what prevents Lompoc from taking this approach.

**Ms. Alarcon** stated the City of Lompoc adopted Inclusionary Housing Policy and including the policy would require approval from the State. **Ms. Alarcon** stated that Lompoc's housing program has helped 58 Lompoc households purchase their first home in Lompoc. This program would not survive if the city did not have in lieu fees directed to the program and the program will continue to be successful as long as the city can incentivize developers to pay the fees. **Ms. Alarcon** stated that lowering the in lieu fee would incentivize housing productions while the state encourages cities to adopt policies that will accelerate housing productions.

**Commissioner Caudillo** inquired if previously approved projects would be eligible for the lower fee.

**Jeff Malawy, City Attorney,** stated that the applicant could request the updated in lieu fee from Council.

**Commissioner Cion**i agreed with Mr. Bridge that lowering the in lieu fee will put pressure on the housing prices and that the HAP program creates opportunities for lower income families to own a house, but does not solve the problem on creating more houses, just creates more demand.

**Ms. Alarcon** clarified that this would not eliminate affordable housing in Lompoc but that it would just be funded differently.

### MOTION:

It was moved by **Commissioner Gonzales**, seconded by **Commissioner Badertscher**, that the **Commission** adopt Resolution No. 965 (22) recommending the City Council adopt proposed amendments to Chapter 17.324 and Chapter 17.704 of the Lompoc Municipal Code regarding Inclusionary Housing In-Lieu Fee Payments (TA 22-01) based upon the Findings in the Resolution.

- The Commission requested that the Council consider restricting the in-lieu fees to the Housing Assistance Program
- The **Commission** requested an annual status report with a review of the in-lieu fee calculations

Review and consideration of recommendations to the Council regarding the Lompoc Streetscape Multi-Modal Improvement Plan for conceptual transportation improvements relating to traffic safety, bicycle and pedestrian improvements, multi-modal connections, corridor and landscaping enhancements along H Street and Ocean Avenue (State Highways 1 and 246).
