A Resolution of the City Council of the City of Lompoc, County of Santa Barbara, State of California, Amending the Classification and Compensation Plans, for Unrepresented Employees to Change the Senior Neighborhood Preservation Officer Job Title to Senior Code Enforcement Officer

- **WHEREAS,** on September 7, 2021, the City Council of the City of Lompoc (City) adopted Resolution No. 6446(21) approving the Senior Neighborhood Preservation Officer job classification and compensation and deleting the Senior Code Enforcement Officer job classification and compensation; and
- **WHEREAS**, recruitment for the Senior Neighborhood Preservation Officer commenced after the adoption of Resolution No. 6446(21); and
- **WHEREAS**, the City has not been able to fill the Senior Neighborhood Preservation Officer position due to insufficient number of qualified applications received; and
- **WHEREAS,** the City's Classification and Compensation Plans must be amended to include the proposed title change for the Senior Code Enforcement Officer job classification, attached hereto as Exhibit A; and
- **WHEREAS,** the City's Compensation Plan must also be amended to reflect the inclusion of the salary for the renamed Senior Code Enforcement Officer, as detailed in Exhibit B attached hereto; and
- **WHEREAS**, Rule III, Section 1 and 2 of the Personnel Rules of the City provide for the adoption, amendment and revision of the Classification Plan; and
- **WHEREAS**, Rule IV, Section 1 and 2 of the Personnel Rules of the City provide for the adoption, amendment, and revision of the Compensation Plan; and
- **WHEREAS**, the City Council desires to amend the Classification and Compensation Plans.
- NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LOMPOC, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
- **SECTION 1.** The Classification Plan, designated as Exhibit A of Personnel Rule III, Section 1, is hereby amended to add the Senior Code Enforcement Officer job classification (with job description attached hereto as Exhibit A) and delete the Senior Neighborhood Preservation Officer job classification.
- **SECTION 2**. The revised (title change only) job description attached hereto as Exhibit A is hereby approved.
