NOTICE IS HEREBY GIVEN that the Lompoc Planning Commission will conduct a public hearing on **Wednesday, October 12, 2022**, at 6:30 p.m. in the City Council Chambers, City Hall, 100 Civic Center Plaza, to consider the following items:

Conditional Use Permit (Permit Modification) for ORGN Cannabis Facility (CUP 19-06)

Planning Commission consideration of a permit modification to an approved Conditional Use Permit (CUP 19-06) for the ORGN cannabis facility to allow the operation of a non-storefront retail cannabis dispensary (delivery service, not open to the public), processing (drying, curing, trimming, and packaging of pre-rolls and flower cannabis for distribution), non-volatile manufacturing (vape pen cartridge filling only), and distribution facility within an existing building in the Industrial (I) zone on approximately 0.72 acres located at 1551 East Laurel Avenue (APN: 099-500-003). This action is categorically exempt from environmental review pursuant to Section 15301 (Existing Facilities) of the California Environmental Quality Act (CEQA) Guidelines.

Any person may appeal a decision of the Planning Commission to the City Council within ten (10) calendar days, or as otherwise specified in the City Code, from the date of the decision. If the Planning Commission action is a recommendation, the action will be heard by City Council, and no appeal is needed. The appeal fee is \$257.80. Pursuant to Government Code requirements, this agenda is posted 72 hours in advance of the meeting in the lobby of City Hall and in the Lompoc Library.
