

ORDINANCE NO. 1448(99)

AN ORDINANCE OF THE CITY OF LOMPOC, CALIFORNIA
AMENDING LOMPOC CITY CODE SECTION 0201.1 PERTAINING TO
SALARIES OF THE MAYOR AND COUNCILMEMBERS
AND REPEALING SECTIONS 0201.2, 0201.3, 0201.4, 0201.5, AND 0201.6

THE CITY COUNCIL OF THE CITY OF LOMPOC DOES ORDAIN AS FOLLOWS:

SECTION 1. Lompoc City Code Section 0201.1 is amended to read as follows:

"Section 0201.1. Salaries of Councilmembers.

- A. Councilmembers' salaries shall be based on the population of the City of Lompoc, as determined by federal census or estimate validated by the California Department of Finance or similar entity. As of January 1, 1999 the population of the City of Lompoc was 42,432 persons.
- B. Inasmuch as the last Councilmember salary adjustment was approved in 1985 and became effective in 1986, the salaries authorized herein are adopted pursuant to the authority of California Government Code Section 36516(c).
- C. Each member of the City Council, including the Mayor, shall receive, as salary, \$600.00 per month.
- D. The elected Mayor shall receive additional compensation of \$200.00 per month.
- E. The salaries authorized are exclusive of any amounts payable to each Councilmember as reimbursement for actual and necessary expenses incurred in the performance of official duties for the City. The salaries authorized are exclusive of health insurance and other benefits accruing to Councilmembers.
- F. Councilmember salaries are payable at the same time and in the same manner as salaries paid to officers and employees of the City of Lompoc.
- G. In accordance with Government Code Section 36516.5, the compensation established by this Section shall be payable on and after the date of commencement of a new term of office by one or more Councilmembers.

SECTION 2. Lompoc City Code Sections 0201.2, 0201.3, 0201.4, 0201.5, and 0201.6 are repealed.

SECTION 3. Ordinances No. 783(66) and 1238(85) are repealed.

SECTION 4. This Ordinance is effective on and after the thirty-first day following its adoption.


